JOINING OR FORMING A STUDY GROUP CAN PROVIDE ACCOUNTABILITY AND SUPPORT. CANDIDATES CAN BENEFIT FROM:

- SHARING RESOURCES AND STUDY MATERIALS.
- DISCUSSING CHALLENGING CONCEPTS WITH PEERS.
- PRACTICING PRACTICAL SKILLS IN A COLLABORATIVE ENVIRONMENT.

STUDY GROUPS FOSTER A SENSE OF COMMUNITY AND CAN MAKE STUDYING MORE ENJOYABLE.

THE DAY OF THE EXAM

ON THE DAY OF THE 2023 ESTHETICIAN STATE BOARD EXAM, CANDIDATES SHOULD BE WELL-PREPARED AND READY TO PERFORM AT THEIR BEST. HERE ARE SOME TIPS FOR THE DAY OF THE EXAM:

WHAT TO BRING

EXAM STRATEGIES

DURING THE EXAM, CANDIDATES SHOULD CONSIDER THE FOLLOWING STRATEGIES:

- READ EACH QUESTION CAREFULLY, ESPECIALLY IN THE THEORETICAL SECTION, TO AVOID MISUNDERSTANDINGS.
- MANAGE TIME EFFECTIVELY; IF A QUESTION IS PARTICULARLY CHALLENGING, MOVE ON AND RETURN TO IT LATER.
- IN THE PRACTICAL EXAM, DEMONSTRATE PROFESSIONALISM AND COMMUNICATION SKILLS, AS THESE ARE OFTEN ASSESSED.

CANDIDATES SHOULD REMEMBER THAT THE STATE BOARD EXAM IS NOT JUST A TEST OF KNOWLEDGE, BUT ALSO AN EVALUATION OF THEIR ABILITY TO PERFORM EFFECTIVELY IN A REAL-WORLD SETTING.

AFTER THE EXAM

ONCE CANDIDATES COMPLETE THE 2023 ESTHETICIAN STATE BOARD EXAM, THEY WILL EAGERLY AWAIT THEIR RESULTS. HERE'S WHAT TO EXPECT:

RECEIVING RESULTS

- SEEKING EMPLOYMENT IN SALONS, SPAS, OR STARTING AN INDEPENDENT PRACTICE.
- CONTINUING EDUCATION TO STAY UPDATED ON INDUSTRY TRENDS AND BEST PRACTICES.

ESTHETICIANS SHOULD ALSO CONSIDER NETWORKING WITH PROFESSIONALS IN THE INDUSTRY TO EXPLORE OPPORTUNITIES FOR GROWTH AND DEVELOPMENT.
