APPLYING LOGARITHMS

IN CASES WHERE THE BASES CANNOT BE MADE THE SAME, LOGARITHMS PROVIDE A POWERFUL TOOL FOR ISOLATING THE EXPONENT VARIABLE. TAKING THE LOGARITHM OF BOTH SIDES, SUCH AS IN $3^x = 20$, ALLOWS THE EQUATION TO BE REWRITTEN AS $x \log 3 = \log 20$. SOLVING FOR x THEN BECOMES STRAIGHTFORWARD. BOTH NATURAL LOGARITHMS (LN) AND COMMON LOGARITHMS (LOG BASE 10) ARE COMMONLY USED.

USING SUBSTITUTION

FOR MORE COMPLEX EXPONENTIAL EQUATIONS, SUBSTITUTION METHODS CAN SIMPLIFY THE PROBLEM. FOR EXAMPLE, AN EQUATION LIKE $2^{2x} - 5 \cdot 2^x + 6 = 0$ CAN BE REWRITTEN BY LETTING $y = 2^x$. THIS TRANSFORMS THE EQUATION INTO A QUADRATIC FORM, $y^2 - 5y + 6 = 0$, WHICH IS SOLVABLE BY FACTORING OR THE QUADRATIC FORMULA. AFTER FINDING VALUES FOR y , BACK-SUBSTITUTION YIELDS SOLUTIONS FOR x .

INTRODUCTION TO EXPONENTIAL INEQUALITIES

EXPONENTIAL INEQUALITIES INVOLVE EXPRESSIONS WHERE THE VARIABLE APPEARS AS AN EXPONENT, AND THE RELATIONSHIP IS EXPRESSED USING INEQUALITY SYMBOLS SUCH AS $<$, $>$, $\leq$, OR $\geq$. THESE INEQUALITIES EXTEND THE CONCEPTS OF EXPONENTIAL EQUATIONS BY INTRODUCING COMPARISON RATHER THAN EQUALITY. GRAPHICAL INTERPRETATION

REWRITING WITH COMMON BASES

FOR INSTANCE, SOLVING $4^x > 16$ CAN BE REWRITTEN AS $(2^2)^x > 2^4$, WHICH SIMPLIFIES TO $2^{2x} > 2^4$. SINCE THE BASE 2 IS GREATER THAN 1, THE INEQUALITY REDUCES TO $2x > 4$, GIVING $x > 2$ AS THE SOLUTION.

APPLYING LOGARITHMS TO INEQUALITIES

WHEN COMMON BASES ARE NOT READILY AVAILABLE, LOGARITHMS ARE EMPLOYED TO SOLVE EXPONENTIAL INEQUALITIES. IT IS CRUCIAL TO REMEMBER THAT THE INEQUALITY DIRECTION REVERSES WHEN MULTIPLYING OR DIVIDING BY NEGATIVE NUMBERS, BUT SINCE LOGARITHMS OF POSITIVE BASES GREATER THAN 1 ARE INCREASING FUNCTIONS, THE INEQUALITY DIRECTION REMAINS THE SAME. FOR EXAMPLE, TO SOLVE $3^x < 15$, TAKING LOGARITHMS ON BOTH SIDES GIVES $x \log 3 < \log 15$, SO $x < \frac{\log 15}{\log 3}$.

CONSIDERING THE BASE'S RANGE

THE BEHAVIOR OF THE EXPONENTIAL FUNCTION CHANGES DEPENDING ON WHETHER THE BASE IS GREATER THAN 1 OR BETWEEN 0 AND 1. THIS IMPACTS HOW INEQUALITIES ARE SOLVED, PARTICULARLY REGARDING THE DIRECTION OF THE INEQUALITY WHEN TAKING LOGARITHMS OR COMPARING EXPRESSIONS. EXPONENTIAL FUNCTIONS ARE DEFINED FOR ALL REAL EXPONENTS, BUT THE SOLUTIONS MUST OFTEN SATISFY DOMAIN CONSTRAINTS, ESPECIALLY WHEN VARIABLES APPEAR IN DENOMINATORS OR UNDER RADICALS. OVERLOOKING THESE RESTRICTIONS CAN LEAD TO EXTRANEIOUS SOLUTIONS.

FAILING TO CHECK SOLUTIONS

AFTER SOLVING EQUATIONS OR INEQUALITIES, VERIFICATION BY SUBSTITUTION OR GRAPHING IS A CRITICAL STEP OFTEN SKIPPED. CHECKING SOLUTIONS ENSURES THAT THEY SATISFY THE ORIGINAL PROBLEM AND HELPS IDENTIFY ERRORS MADE DURING MANIPULATION.

PRACTICE PROBLEMS AND SOLUTIONS

PROBLEM: SOLVE $3^x > 27$.

SOLUTION: REWRITE 27 AS 3^3 . SINCE THE BASE $3 > 1$, INEQUALITY DIRECTION REMAINS: $x > 3$.

4.

PROBLEM: SOLVE $4^x \leq \frac{1}{16}$.

SOLUTION: REWRITE 4 AS 2^2 AND $\frac{1}{16}$ AS 2^{-4} . SO, $(2^2)^x \leq 2^{-4}$ WHICH IS $2^{2x} \leq 2^{-4}$. BECAUSE BASE $2 > 1$, INEQUALITY DIRECTION STAYS: $2x \leq -4$, HENCE $x \leq -2$.

5.

PROBLEM: SOLVE $2^{2x} - 5 \cdot 2^x + 6 = 0$.

SOLUTION: LET $y = 2^x$. THE EQUATION BECOMES $y^2 - 5y + 6 = 0$. FACTOR AS $(y - 2)(y - 3) = 0$, SO $y = 2$ OR $y = 3$. BACK-SUBSTITUTE: $2^x = 2$ IMPLIES $x = 1$, AND $2^x = 3$ IMPLIES $x = \log_2 3$.
