OVERVIEW OF 97035 CPT CODE PHYSICAL THERAPY

PHYSIOLOGICAL EFFECTS OF THERAPEUTIC ULTRASOUND

THE ULTRASOUND WAVES CREATE MECHANICAL VIBRATIONS IN TISSUES, WHICH PRODUCE THERMAL AND NON-THERMAL EFFECTS. THERMAL EFFECTS INCREASE LOCAL BLOOD FLOW AND TISSUE EXTENSIBILITY, WHILE NON-THERMAL EFFECTS PROMOTE CELL MEMBRANE PERMEABILITY AND ACCELERATE THE INFLAMMATORY RESPONSE NECESSARY FOR HEALING. THESE COMBINED EFFECTS UNDERPIN THE CLINICAL UTILITY OF THE 97035 CPT CODE PHYSICAL THERAPY TREATMENT.

BILLING AND CODING GUIDELINES FOR 97035

ACCURATE BILLING AND CODING PRACTICES ARE IMPERATIVE FOR PHYSICAL THERAPY PROVIDERS TO SECURE APPROPRIATE REIMBURSEMENT FOR ULTRASOUND THERAPY SERVICES. THE 97035 CPT CODE PHYSICAL THERAPY MUST BE APPLIED IN ACCORDANCE WITH ESTABLISHED CODING GUIDELINES TO AVOID CLAIM DENIALS AND AUDITS.

WHEN TO USE 97035 CPT CODE

THE 97035 CODE SHOULD BE REPORTED WHEN THERAPEUTIC ULTRASOUND IS ADMINISTERED AS A STANDALONE PROCEDURE OR IN CONJUNCTION WITH OTHER PHYSICAL THERAPY TREATMENTS DURING THE SAME VISIT. IT IS IMPORTANT TO NOTE THAT THE CODE REPRESENTS ONE UNIT OF SERVICE PER TREATMENT SESSION PER PATIENT, REGARDLESS OF THE NUMBER OF TREATMENT AREAS ADDRESSED.

MODIFIERS AND UNITS OF SERVICE

IN CERTAIN CASES, MODIFIERS MAY BE NECESSARY TO CLARIFY BILLING SITUATIONS, SUCH AS:

- **MODIFIER 59:** TO INDICATE DISTINCT PROCEDURAL SERVICES WHEN ULTRASOUND IS PERFORMED ON SEPARATE ANATOMICAL REGIONS DURING THE SAME SESSION.

- **MODIFIER GP:** TO DENOTE SERVICES PROVIDED UNDER A PHYSICAL THERAPY PLAN OF CARE.

FAILURE TO PROVIDE ADEQUATE DOCUMENTATION FOR 97035 CAN RESULT IN CLAIM DENIALS OR RECOUPMENTS. PROVIDERS SHOULD ESTABLISH ROBUST DOCUMENTATION PROTOCOLS AND CONDUCT PERIODIC INTERNAL REVIEWS TO ENSURE COMPLIANCE.

COMMON CHALLENGES AND SOLUTIONS IN USING 97035 CPT CODE
