UNDERSTANDING VOLUME PRICE ANALYSIS

THE ROLE OF VOLUME IN MARKET ANALYSIS

A BREAKOUT ABOVE RESISTANCE OR BELOW SUPPORT IS MORE RELIABLE WHEN ACCOMPANIED BY A SIGNIFICANT INCREASE IN VOLUME. THIS CONFIRMS GENUINE BUYING OR SELLING INTEREST AND REDUCES THE RISK OF FALSE BREAKOUTS.

VOLUME CLIMAX AND REVERSALS

VOLUME CLIMAXES ARE MARKED BY UNUSUALLY HIGH VOLUME AT THE END OF A TREND, OFTEN SIGNALING EXHAUSTION AND A POTENTIAL REVERSAL. COULLING HIGHLIGHTS THAT THESE CLIMAXES TYPICALLY COINCIDE WITH WIDE PRICE BARS AND SUDDEN SHIFTS IN MARKET SENTIMENT.
