A GUIDE FOR WISCONSIN NONPROFIT ORGANIZATIONS IS ESSENTIAL FOR ANYONE LOOKING TO UNDERSTAND THE INTRICACIES OF ESTABLISHING AND MANAGING A NONPROFIT IN THE BADGER STATE. NONPROFITS PLAY A CRITICAL ROLE IN COMMUNITY DEVELOPMENT, SOCIAL SERVICES, EDUCATION, AND VARIOUS OTHER SECTORS. THIS GUIDE WILL PROVIDE A COMPREHENSIVE OVERVIEW OF THE NECESSARY STEPS, LEGAL REQUIREMENTS, FUNDING OPPORTUNITIES, AND BEST PRACTICES FOR OPERATING A NONPROFIT ORGANIZATION IN WISCONSIN.

UNDERSTANDING NONPROFIT ORGANIZATIONS IN WISCONSIN

NONPROFIT ORGANIZATIONS IN WISCONSIN SERVE VARIOUS COMMUNITY NEEDS AND ARE CHARACTERIZED BY THEIR MISSION-DRIVEN FOCUS. UNLIKE FOR-PROFIT ENTITIES, NONPROFITS DO NOT DISTRIBUTE PROFITS TO SHAREHOLDERS BUT REINVEST THEM INTO THEIR PROGRAMS AND SERVICES.

TYPES OF NONPROFITS

1. CHARITABLE ORGANIZATIONS: THESE ORGANIZATIONS FOCUS ON PHILANTHROPY, PROVIDING SERVICES SUCH AS FOOD ASSISTANCE, HOUSING, AND EDUCATION.
2. ADVOCACY GROUPS: NONPROFITS THAT ADVOCATE FOR SOCIAL CHANGE, ENVIRONMENTAL PROTECTION, OR SPECIFIC POPULATIONS.
3. CULTURAL INSTITUTIONS: MUSEUMS, THEATERS, AND OTHER ORGANIZATIONS THAT PROMOTE ARTS AND CULTURE.
4. PROFESSIONAL ASSOCIATIONS: GROUPS THAT SERVE THE INTERESTS OF A PARTICULAR PROFESSION OR TRADE.

STEPS TO ESTABLISH A NONPROFIT ORGANIZATION IN WISCONSIN

STARTING A NONPROFIT ORGANIZATION REQUIRES CAREFUL PLANNING AND ADHERENCE TO LEGAL REQUIREMENTS. BELOW ARE THE KEY STEPS INVOLVED.

1. DEFINE YOUR MISSION AND VISION

BEFORE STARTING A NONPROFIT, CLEARLY OUTLINE YOUR MISSION AND VISION. THIS WILL GUIDE YOUR ORGANIZATION'S ACTIVITIES AND HELP ATTRACT SUPPORTERS.

- MISSION STATEMENT: A CONCISE STATEMENT DEFINING THE PURPOSE OF YOUR NONPROFIT.
- VISION STATEMENT: A FORWARD-LOOKING STATEMENT THAT ARTICULATES WHAT YOU HOPE TO ACHIEVE IN THE LONG TERM.

2. FORM A BOARD OF DIRECTORS

WISCONSIN LAW REQUIRES NONPROFITS TO HAVE A BOARD OF DIRECTORS. THE BOARD SHOULD CONSIST OF INDIVIDUALS WHO ARE COMMITTED TO THE ORGANIZATION'S MISSION AND BRING A VARIETY OF SKILLS AND PERSPECTIVES.

- MINIMUM REQUIREMENTS: AT LEAST THREE DIRECTORS, WITH A MAJORITY BEING RESIDENTS OF WISCONSIN.
- DUTIES: OVERSEE THE ORGANIZATION, ENSURE COMPLIANCE WITH LEGAL OBLIGATIONS, AND SET STRATEGIC DIRECTION.

3. INCORPORATE YOUR NONPROFIT

INCORPORATION IS CRUCIAL FOR LEGAL PROTECTION AND CREDIBILITY. FOLLOW THESE STEPS:

- CHOOSE A NAME: ENSURE YOUR ORGANIZATION'S NAME IS UNIQUE AND COMPLIES WITH STATE REGULATIONS.
- FILE ARTICLES OF INCORPORATION: SUBMIT THESE TO THE WISCONSIN DEPARTMENT OF FINANCIAL INSTITUTIONS. INCLUDE:
 - ORGANIZATION'S NAME
 - PURPOSE
 - REGISTERED AGENT
 - BOARD MEMBER NAMES AND ADDRESSES
- PAY THE FILING FEE: AS OF 2023, THE FEE IS \$35 FOR ONLINE FILINGS OR \$50 FOR PAPER SUBMISSIONS.

4. APPLY FOR 501(c)(3) TAX-EXEMPT STATUS

TO GAIN FEDERAL TAX-EXEMPT STATUS, YOU MUST APPLY TO THE IRS. THIS IS A CRUCIAL STEP AS IT ALLOWS DONATIONS TO BE TAX-DEDUCTIBLE.

- COMPLETE IRS FORM 1023: THIS APPLICATION REQUIRES DETAILED INFORMATION ABOUT YOUR ORGANIZATION, INCLUDING FINANCIAL PROJECTIONS AND BYLAWS.
- FILE STATE EXEMPTION: AFTER OBTAINING FEDERAL STATUS, APPLY FOR WISCONSIN STATE TAX EXEMPTIONS.

5. CREATE BYLAWS

BYLAWS ARE ESSENTIAL GOVERNANCE DOCUMENTS THAT OUTLINE HOW YOUR ORGANIZATION WILL OPERATE. KEY COMPONENTS INCLUDE:

- BOARD STRUCTURE: ROLES AND RESPONSIBILITIES OF BOARD MEMBERS.
- MEETINGS: FREQUENCY OF BOARD MEETINGS AND VOTING PROCEDURES.
- CONFLICT OF INTEREST POLICY: GUIDELINES TO HANDLE POTENTIAL CONFLICTS AMONG BOARD MEMBERS.

LEGAL AND REGULATORY COMPLIANCE

ONCE ESTABLISHED, WISCONSIN NONPROFITS MUST ADHERE TO SPECIFIC LEGAL OBLIGATIONS TO OPERATE EFFECTIVELY AND ETHICALLY.

ANNUAL REPORTING REQUIREMENTS

NONPROFITS IN WISCONSIN MUST FILE CERTAIN REPORTS TO MAINTAIN THEIR STATUS:

- IRS FORM 990: MOST NONPROFITS MUST FILE THIS ANNUAL RETURN, DETAILING FINANCES AND ACTIVITIES.
- WISCONSIN ANNUAL REPORT: FILE WITH THE DEPARTMENT OF FINANCIAL INSTITUTIONS TO KEEP YOUR INCORPORATION STATUS ACTIVE.

LICENSING AND PERMITS

DEPENDING ON YOUR NONPROFIT'S ACTIVITIES, ADDITIONAL LICENSES OR PERMITS MAY BE REQUIRED:

- FUNDRAISING REGISTRATION: IF YOUR ORGANIZATION SOLICITS DONATIONS, REGISTER WITH THE WISCONSIN DEPARTMENT OF FINANCIAL INSTITUTIONS.
- BUSINESS LICENSES: IF APPLICABLE, ACQUIRE LOCAL BUSINESS LICENSES FOR OPERATIONAL ACTIVITIES.

FUNDING OPPORTUNITIES FOR WISCONSIN NONPROFITS

SECURING FUNDING IS VITAL FOR THE SUSTAINABILITY OF ANY NONPROFIT. HERE ARE SEVERAL AVENUES TO EXPLORE:

1. GRANTS

NUMEROUS FOUNDATIONS AND GOVERNMENT ENTITIES OFFER GRANTS TO WISCONSIN NONPROFITS. KEY RESOURCES INCLUDE:

- WISCONSIN DEPARTMENT OF ADMINISTRATION: PROVIDES INFORMATION ON STATE GRANT OPPORTUNITIES.
- LOCAL FOUNDATIONS: RESEARCH COMMUNITY FOUNDATIONS THAT SUPPORT REGIONAL CAUSES.

2. INDIVIDUAL DONATIONS

CULTIVATING RELATIONSHIPS WITH INDIVIDUAL DONORS CAN PROVIDE A RELIABLE FUNDING SOURCE. STRATEGIES INCLUDE:

- FLEXIBLE: ALLOW FOR ADJUSTMENTS AS CIRCUMSTANCES CHANGE.

2. BUILD A STRONG COMMUNITY PRESENCE

ENGAGING WITH THE COMMUNITY STRENGTHENS YOUR NONPROFIT'S IMPACT. STRATEGIES INCLUDE:

- VOLUNTEER PROGRAMS: CREATE OPPORTUNITIES FOR COMMUNITY MEMBERS TO GET INVOLVED.
- PARTNERSHIPS: COLLABORATE WITH OTHER NONPROFITS AND ORGANIZATIONS FOR MUTUAL BENEFIT.

3. MAINTAIN FINANCIAL TRANSPARENCY

TRANSPARENCY FOSTERS TRUST AND CREDIBILITY. BEST PRACTICES INCLUDE:

- REGULAR FINANCIAL REPORTING: PROVIDE UPDATES TO THE BOARD AND STAKEHOLDERS.
- OPEN ACCESS: MAKE FINANCIAL STATEMENTS AVAILABLE TO THE PUBLIC.
