BIOGRAPHY OF YEHUDA BAUER

YEHUDA BAUER IS A DISTINGUISHED ISRAELI HISTORIAN BORN IN 1926 IN CZECHOSLOVAKIA. HE IS WIDELY REGARDED AS ONE OF THE LEADING SCHOLARS IN HOLOCAUST STUDIES. BAUER'S DEFINITION AND INTERPRETATION OF THE HOLOCAUST

CAUSES AND ORIGINS OF THE HOLOCAUST ACCORDING TO YEHUDA BAUER

IN BAUER'S ANALYSIS, THE HOLOCAUST'S ORIGINS ARE COMPLEX AND MULTIFACETED, COMBINING HISTORICAL ANTISEMITISM, POLITICAL DEVELOPMENTS, AND THE SPECIFIC CONTEXT OF NAZI GERMANY. THE ROLE OF PERPETRATORS AND VICTIMS
