THE PRIMARY CERTIFICATION RECOGNIZED BY THE ABA IS THE PARALEGAL CERTIFICATION THROUGH THE NATIONAL ASSOCIATION OF LEGAL ASSISTANTS (NALA), KNOWN AS THE CERTIFIED PARALEGAL (CP) DESIGNATION.

WHAT IS THE CERTIFIED PARALEGAL (CP) EXAM?

THE CP EXAM IS DESIGNED TO ASSESS A CANDIDATE'S KNOWLEDGE AND SKILLS RELEVANT TO THE PARALEGAL PROFESSION. IT COMPRISES MULTIPLE-CHOICE QUESTIONS AND PRACTICAL TASKS THAT SIMULATE REAL-WORLD LEGAL SCENARIOS. THE EXAM COVERS VARIOUS TOPICS, INCLUDING:

- LEGAL RESEARCH AND WRITING
- ETHICS AND PROFESSIONAL RESPONSIBILITY
- CIVIL LITIGATION
- FAMILY LAW
- CRIMINAL LAW
- CONTRACT LAW

- **PROFESSIONAL DEVELOPMENT:** THE CERTIFICATION PROCESS ENCOURAGES CONTINUOUS LEARNING AND STAYING UPDATED ON LEGAL DEVELOPMENTS.
- **NETWORKING OPPORTUNITIES:** JOINING ORGANIZATIONS THAT SUPPORT CERTIFICATION CAN PROVIDE VALUABLE NETWORKING OPPORTUNITIES WITH OTHER LEGAL PROFESSIONALS.

ELIGIBILITY REQUIREMENTS

BEFORE TAKING THE CP EXAM, CANDIDATES MUST MEET CERTAIN ELIGIBILITY CRITERIA ESTABLISHED BY NALA. THESE REQUIREMENTS GENERALLY INCLUDE:

3. **CONTINUING EDUCATION:** SOME CANDIDATES MAY NEED TO DEMONSTRATE ONGOING EDUCATION IN LEGAL STUDIES OR RELATED FIELDS.

IT IS ESSENTIAL FOR CANDIDATES TO REVIEW NALA'S ELIGIBILITY REQUIREMENTS AS THEY MAY VARY BASED ON INDIVIDUAL CIRCUMSTANCES.

PREPARING FOR THE ABA PARALEGAL CERTIFICATION EXAM

PREPARATION IS KEY TO PASSING THE CP EXAM. BELOW ARE STEPS TO EFFECTIVELY PREPARE FOR THE EXAM:

AFTER THE EXAM: WHAT TO EXPECT

ONCE YOU COMPLETE THE CP EXAM, YOU WILL RECEIVE YOUR RESULTS WITHIN A FEW WEEKS. IF YOU PASS, YOU WILL RECEIVE YOUR CERTIFICATION AND CAN PROUDLY DISPLAY YOUR CP DESIGNATION. IF YOU DO NOT PASS, DO NOT BE DISCOURAGED. MANY CANDIDATES RETAKE THE EXAM AFTER FURTHER PREPARATION AND EVENTUALLY SUCCEED.

CONTINUING EDUCATION AND RECERTIFICATION

CERTIFIED PARALEGALS MUST MAINTAIN THEIR CREDENTIALS THROUGH CONTINUING EDUCATION. NALA REQUIRES CPs TO COMPLETE 50 HOURS OF CONTINUING EDUCATION EVERY FIVE YEARS, WITH AT LEAST 5 HOURS IN ETHICS. THIS REQUIREMENT HELPS ENSURE THAT PARALEGALS REMAIN KNOWLEDGEABLE ABOUT CHANGES IN THE LAW AND BEST PRACTICES IN THE FIELD.

WAYS TO EARN CONTINUING EDUCATION CREDITS

CONTINUING EDUCATION CAN BE OBTAINED THROUGH:

- **WORKSHOPS AND SEMINARS:** ATTEND LEGAL WORKSHOPS AND SEMINARS RELEVANT TO YOUR PRACTICE AREA.
- **ONLINE COURSES:** MANY ORGANIZATIONS OFFER ONLINE COURSES THAT COUNT TOWARD CONTINUING EDUCATION CREDITS.
- **PROFESSIONAL CONFERENCES:** PARTICIPATE IN LEGAL CONFERENCES TO NETWORK AND LEARN FROM INDUSTRY LEADERS.
- **WEBINARS AND PODCASTS:** ENGAGE WITH ONLINE CONTENT THAT PROVIDES INSIGHTS INTO CURRENT LEGAL ISSUES AND TRENDS.
