THE FLORIDA BOARD OF NURSING, WHICH OPERATES UNDER THE DEPARTMENT OF HEALTH, IS RESPONSIBLE FOR ENFORCING THESE REGULATIONS AND ENSURING THAT NURSING PROFESSIONALS ADHERE TO THE STANDARDS SET FORTH IN THE NURSE PRACTICE ACT. UNDERSTANDING THE ADMINISTRATIVE CODES IS CRUCIAL FOR NURSES, NURSING STUDENTS, AND HEALTHCARE EMPLOYERS TO ENSURE COMPLIANCE AND MAINTAIN PATIENT SAFETY.

OVERVIEW OF THE FLORIDA NURSE PRACTICE ACT

THE FLORIDA NURSE PRACTICE ACT SERVES AS THE FOUNDATION FOR NURSING PRACTICE IN THE STATE. IT ESTABLISHES:

- THE SCOPE OF NURSING PRACTICE
- LICENSURE REQUIREMENTS
- DISCIPLINARY ACTIONS FOR VIOLATIONS
- CONTINUING EDUCATION MANDATES

BY CLEARLY DEFINING THESE ESSENTIAL ELEMENTS, THE ACT HELPS TO PROTECT THE PUBLIC BY ENSURING THAT ONLY QUALIFIED INDIVIDUALS PROVIDE NURSING CARE.

LICENSURE REQUIREMENTS

TO PRACTICE NURSING IN FLORIDA, INDIVIDUALS MUST OBTAIN A NURSING LICENSE FROM THE FLORIDA BOARD OF NURSING. THE ADMINISTRATIVE CODES OUTLINE THE FOLLOWING REQUIREMENTS FOR LICENSURE:

1. **EDUCATIONAL QUALIFICATIONS:** CANDIDATES MUST GRADUATE FROM A BOARD-APPROVED NURSING PROGRAM (EITHER A REGISTERED NURSE (RN) OR LICENSED PRACTICAL NURSE (LPN) PROGRAM).
2. **EXAMINATION:** AFTER COMPLETING THEIR EDUCATION, CANDIDATES MUST PASS THE NATIONAL COUNCIL LICENSURE EXAMINATION (NCLEX-RN OR NCLEX-PN).
3. **BACKGROUND CHECK:** CANDIDATES MUST UNDERGO A CRIMINAL BACKGROUND CHECK, WHICH IS MANDATORY FOR ALL NURSING APPLICANTS.
4. **APPLICATION PROCESS:** APPLICANTS MUST SUBMIT A COMPLETED APPLICATION, INCLUDING PROOF OF EDUCATION, EXAMINATION RESULTS, AND PAYMENT OF APPLICABLE FEES.
5. **FOREIGN-EDUCATED NURSES:** NURSES WHO HAVE GRADUATED FROM PROGRAMS OUTSIDE THE UNITED STATES MUST MEET ADDITIONAL REQUIREMENTS, INCLUDING CREDENTIAL EVALUATION AND ENGLISH PROFICIENCY TESTING.

SCOPE OF PRACTICE

THE ADMINISTRATIVE CODES DELINEATE THE SCOPE OF PRACTICE FOR RNS AND LPNS, ENSURING THAT NURSES OPERATE WITHIN

THEIR TRAINING AND EDUCATION LEVELS. KEY ELEMENTS INCLUDE:

- REGISTERED NURSES (RNs): RNs CAN PERFORM COMPREHENSIVE ASSESSMENTS, DEVELOP NURSING DIAGNOSES, PLAN AND IMPLEMENT INTERVENTIONS, AND EVALUATE PATIENT OUTCOMES. THEY MAY ALSO DELEGATE TASKS TO LPNs AND UNLICENSED ASSISTIVE PERSONNEL.
- LICENSED PRACTICAL NURSES (LPNs): LPNs PROVIDE BASIC NURSING CARE UNDER THE SUPERVISION OF RNs OR PHYSICIANS. THEIR SCOPE INCLUDES MONITORING PATIENT HEALTH, ADMINISTERING MEDICATIONS, AND ASSISTING WITH DAILY LIVING ACTIVITIES.

UNDERSTANDING THESE DISTINCTIONS IS VITAL FOR NURSES TO AVOID PRACTICING OUTSIDE THEIR AUTHORIZED SCOPE, WHICH CAN LEAD TO DISCIPLINARY ACTIONS.

DISCIPLINARY ACTIONS AND VIOLATIONS

THE FLORIDA NURSE PRACTICE ACT INCLUDES PROVISIONS FOR DISCIPLINARY ACTIONS AGAINST NURSING PROFESSIONALS WHO VIOLATE THE ESTABLISHED CODES. THE ADMINISTRATIVE CODES SPECIFY VARIOUS GROUNDS FOR DISCIPLINARY ACTION, INCLUDING:

- UNPROFESSIONAL CONDUCT: ENGAGING IN BEHAVIOR THAT IS DEEMED UNETHICAL OR UNPROFESSIONAL.
- SUBSTANCE ABUSE: BEING IMPAIRED DUE TO DRUG OR ALCOHOL USE WHILE ON DUTY.
- CRIMINAL CONVICTIONS: CERTAIN FELONY OR MISDEMEANOR CONVICTIONS CAN RESULT IN DISCIPLINARY ACTIONS OR DENIAL OF LICENSURE.
- NEGLIGENCE OR MALPRACTICE: FAILING TO MEET THE STANDARD OF CARE EXPECTED IN NURSING PRACTICE, RESULTING IN PATIENT HARM.
- FRAUDULENT ACTIVITIES: ENGAGING IN FRAUD, SUCH AS FALSIFYING DOCUMENTS OR MISREPRESENTING QUALIFICATIONS.

DISCIPLINARY ACTIONS MAY INCLUDE FINES, SUSPENSION, REVOCATION OF LICENSURE, OR MANDATORY REMEDIATION PROGRAMS. THE SEVERITY OF THE PENALTY OFTEN DEPENDS ON THE NATURE OF THE VIOLATION AND THE NURSE'S HISTORY.

CONTINUING EDUCATION REQUIREMENTS

TO MAINTAIN THEIR NURSING LICENSES, FLORIDA NURSES MUST FULFILL SPECIFIC CONTINUING EDUCATION (CE) REQUIREMENTS. THE ADMINISTRATIVE CODES MANDATE THAT:

- RNs AND LPNs MUST COMPLETE 24 HOURS OF CONTINUING EDUCATION EVERY TWO YEARS, WHICH INCLUDES A MINIMUM OF 2 HOURS IN THE PREVENTION OF MEDICAL ERRORS AND 2 HOURS IN THE TOPICS OF HUMAN TRAFFICKING.
- ADVANCED PRACTICE REGISTERED NURSES (APRNs) HAVE ADDITIONAL REQUIREMENTS, INCLUDING SPECIFIC CE RELATED TO THEIR SPECIALIZED AREA OF PRACTICE.

CONTINUING EDUCATION ENSURES THAT NURSES STAY CURRENT WITH THE LATEST DEVELOPMENTS IN MEDICAL SCIENCE, TECHNOLOGY, AND BEST PRACTICES, ULTIMATELY BENEFITING PATIENT CARE.

FLORIDA ADMINISTRATIVE CODE SECTIONS RELEVANT TO NURSING PRACTICE

- FAC 64B9-5: THIS SECTION ENCOMPASSES THE GROUNDS FOR DISCIPLINARY ACTION AND THE PROCEDURES FOR ADDRESSING VIOLATIONS.

EACH SECTION OF THE FLORIDA ADMINISTRATIVE CODE PLAYS A CRUCIAL ROLE IN SHAPING THE STANDARDS OF NURSING PRACTICE AND ENSURING ACCOUNTABILITY WITHIN THE PROFESSION.
