BACKGROUND AND HISTORICAL CONTEXT OF ALBERT TUCKER

THE ANGRY PENGUINS AND ARTISTIC CIRCLES

THE ANGRY PENGUINS MOVEMENT, TO WHICH TUCKER BELONGED, EMBRACED MODERNISM AND SURREALISM AS VEHICLES FOR CONFRONTING SOCIAL AND PSYCHOLOGICAL TRUTHS. THIS GROUP'S INTELLECTUAL AND ARTISTIC ENVIRONMENT ENCOURAGED TUCKER TO EXPERIMENT WITH FORM AND CONTENT, RESULTING IN HIS DISTINCTIVE PORTRAYAL OF EVIL AS BOTH A SOCIETAL AND PERSONAL PHENOMENON. THE INFLUENCE OF CONTEMPORARIES AND INTERNATIONAL ART TRENDS IS EVIDENT IN HIS APPROACH TO REPRESENTING THE DARKER ASPECTS OF HUMAN EXPERIENCE.

KEY THEMES IN ALBERT TUCKER'S IMAGES OF MODERN EVIL

CORRUPTION AND MORAL DECAY

CORRUPTION—BOTH PERSONAL AND SOCIETAL—IS ANOTHER CRITICAL THEME IN TUCKER'S IMAGERY. STYLISTIC CHARACTERISTICS AND ARTISTIC TECHNIQUES

THE COLOR SCHEMES IN TUCKER'S WORK OFTEN INCLUDE STARK CONTRASTS, WITH DARK TONES JUXTAPOSED AGAINST VIVID HUES TO HEIGHTEN DRAMATIC EFFECT. HIS COMPOSITIONS ARE FREQUENTLY CHAOTIC AND FRAGMENTED, REFLECTING THE TUMULTUOUS NATURE OF THE SUBJECT MATTER.
