5. MIND-BODY TECHNIQUES: PRACTICES SUCH AS YOGA AND MEDITATION THAT EMPHASIZE THE CONNECTION BETWEEN MENTAL AND PHYSICAL HEALTH.

OVERVIEW OF AMERICAN RELIGIOUS LIFE

AMERICAN RELIGIOUS LIFE IS CHARACTERIZED BY A DIVERSE SPECTRUM OF BELIEFS, PRACTICES, AND COMMUNITIES.
