TYPES OF FIRE EXTINGUISHERS

THERE ARE SEVERAL TYPES OF FIRE EXTINGUISHERS, EACH SUITED FOR DIFFERENT CLASSES OF FIRES:

- **WATER EXTINGUISHERS:** SUITABLE FOR CLASS A FIRES, THESE EXTINGUISHERS WORK BY COOLING THE FLAMES.

- **WET CHEMICAL EXTINGUISHERS:** SPECIFICALLY DESIGNED FOR CLASS K FIRES, THEY CAN ALSO BE USED ON CLASS A FIRES.

TRAINING REQUIREMENTS FOR EMPLOYEES

MANY ORGANIZATIONS ARE MANDATED TO PROVIDE ANNUAL FIRE EXTINGUISHER TRAINING FOR ALL EMPLOYEES. THE SPECIFICS CAN VARY BASED ON LOCAL REGULATIONS, BUT GENERALLY INCLUDE THE FOLLOWING COMPONENTS:

INITIAL TRAINING

- UPDATES ON ANY CHANGES IN REGULATIONS OR WORKPLACE SAFETY POLICIES.

THEORY IS IMPORTANT, BUT HANDS-ON TRAINING IS CRUCIAL. ALLOW EMPLOYEES TO PRACTICE USING EXTINGUISHERS UNDER CONTROLLED CONDITIONS. THIS PRACTICAL EXPERIENCE HELPS REINFORCE THEIR CONFIDENCE AND COMPETENCE.

4. EVALUATE UNDERSTANDING

AT THE END OF EACH TRAINING SESSION, CONSIDER ADMINISTERING A SHORT QUIZ OR ASSESSMENT TO GAUGE EMPLOYEES' UNDERSTANDING OF THE MATERIAL. THIS CAN HELP IDENTIFY AREAS WHERE ADDITIONAL TRAINING MAY BE NECESSARY.

5. MAINTAIN RECORDS

KEEP DETAILED RECORDS OF ALL TRAINING SESSIONS, INCLUDING ATTENDANCE, CONTENT COVERED, AND ANY ASSESSMENTS CONDUCTED. THIS DOCUMENTATION CAN BE ESSENTIAL FOR COMPLIANCE PURPOSES AND FOR FUTURE TRAINING NEEDS.
