THIS SECTION EVALUATES STUDENTS' ABILITIES TO CONSTRUCT COHERENT ARGUMENTS, ANALYZE POLITICAL SCENARIOS, AND APPLY KNOWLEDGE TO REAL-WORLD CONTEXTS. THE QUESTIONS REQUIRE WRITTEN RESPONSES THAT DEMONSTRATE CRITICAL THINKING, SYNTHESIS OF INFORMATION, AND CLEAR COMMUNICATION. THE FREE-RESPONSE SECTION IS WEIGHTED TO REFLECT ITS IMPORTANCE IN TESTING HIGHER-ORDER THINKING SKILLS IN GOVERNMENT AND POLITICS.

TYPES OF FREE-RESPONSE QUESTIONS

- CONCEPT APPLICATION: EXPLAINING OR APPLYING POLITICAL CONCEPTS
- QUANTITATIVE ANALYSIS: INTERPRETING DATA, CHARTS, OR GRAPHS
- COMPARATIVE ANALYSIS: COMPARING POLITICAL INSTITUTIONS, POLICIES, OR BEHAVIORS
- ARGUMENTATIVE ESSAY: DEVELOPING AN EVIDENCE-BASED ARGUMENT ON A POLITICAL ISSUE

KEY CONTENT AREAS TESTED ON THE EXAM
