- NO CRIMINAL RECORD: CERTAIN CRIMINAL CONVICTIONS CAN DISQUALIFY YOU FROM OBTAINING A LICENSE.

THE APPLICATION PROCESS

ONCE YOU MEET THE ELIGIBILITY REQUIREMENTS, THE NEXT STEP IS TO APPLY FOR YOUR CONTRACTOR'S LICENSE. THIS PROCESS INCLUDES SEVERAL KEY STEPS:

STEP 1: COMPLETE THE APPLICATION

YOU CAN OBTAIN THE APPLICATION FORM FROM THE ARIZONA ROC WEBSITE OR YOUR LOCAL ROC OFFICE. ENSURE THAT YOU PROVIDE ACCURATE AND COMPLETE INFORMATION. THE APPLICATION TYPICALLY REQUIRES:

STEP 4: SCHEDULE THE EXAM
