UNDERSTANDING HAZARDOUS MATERIALS

TYPES OF HAZARDOUS MATERIALS

HAZARDOUS MATERIALS CAN GENERALLY BE CATEGORIZED INTO SEVERAL CLASSIFICATIONS:

1. EXPLOSIVES: SUBSTANCES THAT CAN UNDERGO A RAPID CHEMICAL REACTION PRODUCING GAS AND HEAT.
2. GASES: INCLUDES FLAMMABLE GASES, TOXIC GASES, AND THOSE THAT ARE CORROSIVE.
3. FLAMMABLE LIQUIDS: LIQUIDS THAT HAVE A FLASH POINT BELOW 100°F (37.8°C).
4. COMBUSTIBLE LIQUIDS: LIQUIDS WITH A FLASH POINT AT OR ABOVE 100°F.
5. TOXIC SUBSTANCES: MATERIALS THAT CAN CAUSE HARM OR DEATH THROUGH EXPOSURE VIA INHALATION, INGESTION, OR SKIN CONTACT.
6. RADIOACTIVE MATERIALS: SUBSTANCES THAT EMIT RADIATION AND CAN BE HARMFUL TO HUMAN HEALTH.

ARIZONA HAZMAT REGULATIONS

IN ARIZONA, THE HANDLING AND TRANSPORTATION OF HAZARDOUS MATERIALS ARE GOVERNED BY A COMBINATION OF STATE AND FEDERAL REGULATIONS. FAMILIARITY WITH THESE LAWS IS CRUCIAL FOR ALL HAZMAT PROFESSIONALS.

FEDERAL REGULATIONS

THE KEY FEDERAL AGENCY REGULATING HAZARDOUS MATERIALS IS THE U.S. DEPARTMENT OF TRANSPORTATION (DOT), WHICH OUTLINES THE HAZARDOUS MATERIALS REGULATIONS (HMR) IN TITLE 49 OF THE CODE OF FEDERAL REGULATIONS (CFR). KEY COMPONENTS INCLUDE:

- CLASSIFICATION OF HAZARDOUS MATERIALS: PROPERLY IDENTIFYING AND CLASSIFYING MATERIALS.
- PACKAGING REQUIREMENTS: ENSURING MATERIALS ARE PACKAGED IN ACCORDANCE WITH SAFETY STANDARDS.
- LABELING AND MARKING: CLEARLY LABELING AND MARKING CONTAINERS TO INDICATE THE TYPE OF HAZARD.
- TRAINING REQUIREMENTS: MANDATING THAT EMPLOYEES RECEIVE TRAINING ON THE HANDLING OF HAZARDOUS MATERIALS.

STATE REGULATIONS

IN ADDITION TO FEDERAL REGULATIONS, ARIZONA HAS ITS OWN SET OF GUIDELINES, PRIMARILY ENFORCED BY THE ARIZONA

DEPARTMENT OF ENVIRONMENTAL QUALITY (ADEQ). SOME IMPORTANT REGULATIONS INCLUDE:

- ARIZONA REVISED STATUTES (ARS) §49-701: OUTLINES THE STATE'S HAZARDOUS WASTE MANAGEMENT PROGRAM.
- ARIZONA ADMINISTRATIVE CODE (AAC) R18-8-260: DETAILS REGULATIONS ON THE TRANSPORTATION OF HAZARDOUS MATERIALS.

BOTH FEDERAL AND STATE REGULATIONS EMPHASIZE THE IMPORTANCE OF COMPLIANCE TO ENSURE SAFETY IN HANDLING HAZARDOUS MATERIALS.

HAZMAT TRAINING REQUIREMENTS

- FUNCTION-SPECIFIC TRAINING: FOCUSES ON THE SPECIFIC TASKS AN EMPLOYEE WILL PERFORM CONCERNING HAZMAT.
- SAFETY TRAINING: PROVIDES INFORMATION ON THE SAFE HANDLING OF HAZARDOUS MATERIALS AND EMERGENCY PROCEDURES.

REFRESHER TRAINING

EMPLOYEES MUST RECEIVE REFRESHER TRAINING AT LEAST EVERY THREE YEARS TO STAY UPDATED ON REGULATIONS AND BEST PRACTICES.

HAZMAT SAFETY PROTOCOLS

ESTABLISHING SAFETY PROTOCOLS IS IMPERATIVE FOR MINIMIZING RISKS ASSOCIATED WITH HAZARDOUS MATERIALS. HERE ARE SOME ESSENTIAL SAFETY MEASURES:

PERSONAL PROTECTIVE EQUIPMENT (PPE)

PPE IS CRITICAL IN PROTECTING EMPLOYEES FROM EXPOSURE TO HAZARDOUS SUBSTANCES. DEPENDING ON THE TYPE OF MATERIAL BEING HANDLED, PPE MAY INCLUDE:

- GLOVES
- SAFETY GOGGLES
- RESPIRATORS
- PROTECTIVE CLOTHING
- FACE SHIELDS

EMERGENCY RESPONSE PLANNING

IN THE EVENT OF A HAZARDOUS MATERIALS INCIDENT, HAVING A WELL-DEFINED EMERGENCY RESPONSE PLAN IS ESSENTIAL. KEY COMPONENTS OF AN EFFECTIVE PLAN INCLUDE:

1. IDENTIFICATION OF HAZARDS: UNDERSTAND THE TYPES OF MATERIALS YOUR FACILITY HANDLES.
2. EMERGENCY CONTACTS: MAINTAIN A LIST OF EMERGENCY CONTACTS, INCLUDING LOCAL FIRE DEPARTMENTS AND POISON CONTROL.
3. EVACUATION PROCEDURES: ESTABLISH CLEAR PROCEDURES FOR EVACUATING PERSONNEL IN THE EVENT OF AN EMERGENCY.
4. TRAINING DRILLS: REGULARLY CONDUCT DRILLS TO ENSURE ALL PERSONNEL ARE FAMILIAR WITH EMERGENCY PROCEDURES.

HAZMAT TRANSPORTATION REGULATIONS

TRANSPORTATION OF HAZARDOUS MATERIALS IS SUBJECT TO STRICT REGULATIONS TO ENSURE PUBLIC SAFETY. ARIZONA FOLLOWS FEDERAL GUIDELINES SET BY THE DOT, WHICH INCLUDES:

SHIPPING PAPERS

ALL HAZMAT SHIPMENTS MUST BE ACCOMPANIED BY SHIPPING PAPERS THAT PROVIDE ESSENTIAL INFORMATION, SUCH AS:

- DESCRIPTION OF THE MATERIAL
- QUANTITY
- EMERGENCY CONTACT INFORMATION
- HANDLING INSTRUCTIONS

VEHICLE REQUIREMENTS

VEHICLES TRANSPORTING HAZARDOUS MATERIALS MUST MEET SPECIFIC REQUIREMENTS, INCLUDING:

- PROPER PLACARDING TO INDICATE THE TYPE OF HAZARD.
- COMPLIANCE WITH WEIGHT LIMITS FOR HAZARDOUS MATERIALS.
- REGULAR INSPECTIONS AND MAINTENANCE TO ENSURE VEHICLE SAFETY.
