2. AVOID OVERUSE

- CONSIDER THAT THE INFECTION MAY BE RESISTANT TO CHLORTETRACYCLINE.

IS THERE A WITHDRAWAL PERIOD FOR AUREOMYCIN CRUMBLES BEFORE SLAUGHTER?

YES, THERE IS TYPICALLY A WITHDRAWAL PERIOD OF AT LEAST 5 TO 7 DAYS BEFORE SLAUGHTER TO ENSURE THAT ANTIBIOTIC RESIDUES ARE CLEARED FROM THE ANIMAL'S SYSTEM.
