POLITICAL PARTNERSHIP

- PUBLIC APPEARANCES: OVER TIME, THEY BEGAN TO APPEAR TOGETHER MORE FREQUENTLY, SIGNALING THEIR COMMITMENT TO MOVE FORWARD AS A UNITED FRONT.

POST-PRESIDENCY LIFE

AFTER LEAVING THE WHITE HOUSE IN 2001, BILL AND HILLARY CLINTON TRANSITIONED INTO NEW ROLES, BOTH PERSONALLY AND PROFESSIONALLY.

GLOBAL INITIATIVES

- CLINTON FOUNDATION: TOGETHER, THEY ESTABLISHED THE CLINTON FOUNDATION, FOCUSING ON GLOBAL HEALTH, CLIMATE CHANGE, AND ECONOMIC DEVELOPMENT. THEIR WORK HIGHLIGHTED THEIR SHARED COMMITMENT TO MAKING A POSITIVE IMPACT ON THE WORLD.

- 2016 PRESIDENTIAL CAMPAIGN: HILLARY RAN FOR THE PRESIDENCY IN 2016, BECOMING THE FIRST WOMAN TO BE NOMINATED BY A MAJOR PARTY. BILL SUPPORTED HER THROUGHOUT THE CAMPAIGN, OFTEN APPEARING AT RALLIES AND EVENTS.
- LEGACY BUILDING: THEIR PARTNERSHIP CONTINUED TO EVOLVE AS HILLARY SOUGHT TO ESTABLISH HER LEGACY AS A LEADER AND ADVOCATE FOR WOMEN'S RIGHTS.

- POLITICAL INFLUENCE: THEIR INFLUENCE EXTENDS BEYOND THEIR OWN CAREERS, AS THEY HAVE INSPIRED A NEW GENERATION OF LEADERS IN THE DEMOCRATIC PARTY.
