DEFINING VISION AND MISSION

- VISION: THIS IS A FORWARD-LOOKING STATEMENT THAT DESCRIBES WHAT THE CHURCH ASPIRES TO BECOME IN THE FUTURE. IT IS AN INSPIRATIONAL DEPICTION THAT MOTIVATES THE CONGREGATION.
- MISSION: THIS OUTLINES THE CHURCH'S CURRENT PURPOSE AND THE ACTIONS IT WILL TAKE TO ACHIEVE ITS VISION. IT ACTS AS A GUIDING PRINCIPLE FOR ALL CHURCH ACTIVITIES.

STEPS TO DEVELOP A VISION AND MISSION

1. PRAYER AND REFLECTION: ENGAGE IN PRAYER TO SEEK DIVINE GUIDANCE IN UNDERSTANDING THE CHURCH'S PURPOSE.

2. CONGREGATIONAL INVOLVEMENT: INVOLVE CHURCH MEMBERS IN DISCUSSIONS TO GATHER DIVERSE PERSPECTIVES.
3. RESEARCH AND ANALYSIS: ANALYZE THE COMMUNITY'S NEEDS TO ENSURE THE CHURCH'S MISSION ALIGNS WITH THEM.
4. DRAFTING AND REFINEMENT: CREATE A DRAFT OF THE VISION AND MISSION STATEMENTS AND REFINE THEM BASED ON FEEDBACK.

LEADERSHIP STYLES

MALPHURS EMPHASIZES THAT UNDERSTANDING VARIOUS LEADERSHIP STYLES IS CRUCIAL FOR EFFECTIVE CHURCH MANAGEMENT. DIFFERENT STYLES CAN SIGNIFICANTLY INFLUENCE CHURCH CULTURE AND EFFECTIVENESS.

COMMON LEADERSHIP STYLES

1. AUTHORITATIVE LEADERSHIP: CHARACTERIZED BY STRONG DIRECTION; SUITABLE FOR URGENT SITUATIONS.

- BALANCE STYLES: BE FLEXIBLE AND ADAPT LEADERSHIP STYLES AS NECESSARY TO MEET DIFFERENT SITUATIONS.

CHURCH STRUCTURE

5. DEVELOP A RESOLUTION PLAN: COLLABORATIVELY CREATE A PLAN THAT ADDRESSES THE CONCERNS OF ALL INVOLVED PARTIES.

MINISTRY PLANNING

3. TIMELINE: ESTABLISH A REALISTIC TIMELINE FOR IMPLEMENTING THE PLAN.
4. EVALUATION AND ADJUSTMENT: REGULARLY ASSESS THE PLAN'S EFFECTIVENESS AND MAKE NECESSARY ADJUSTMENTS.

BENEFITS OF EFFECTIVE PLANNING

- ENHANCES FOCUS AND DIRECTION FOR CHURCH ACTIVITIES.
- IMPROVES ACCOUNTABILITY AMONG CHURCH LEADERS AND MEMBERS.
- ENCOURAGES PROACTIVE RATHER THAN REACTIVE MINISTRY EFFORTS.
