

C VANN WOODWARD THE STRANGE CAREER OF JIM CROW

C. VANN WOODWARD'S "THE STRANGE CAREER OF JIM CROW" IS A SEMINAL TEXT THAT EXPLORES THE HISTORICAL EVOLUTION OF RACIAL SEGREGATION IN THE UNITED STATES, PARTICULARLY IN THE SOUTH. THE EMERGENCE OF JIM CROW LAWS

- BY THE LATE 19TH CENTURY, STATES BEGAN TO IMPLEMENT LAWS THAT ENFORCED RACIAL SEGREGATION IN PUBLIC FACILITIES, SCHOOLS, TRANSPORTATION, AND MORE.
- THESE LAWS WERE JUSTIFIED BY THE DOCTRINE OF "SEPARATE BUT EQUAL," WHICH WAS UPHELD BY THE SUPREME COURT IN THE LANDMARK CASE PLESSY V. FERGUSON (1896).
- WOODWARD EMPHASIZES THAT JIM CROW WAS NOT MERELY A SET OF LAWS BUT A COMPREHENSIVE SYSTEM OF SOCIAL CONTROL THAT SOUGHT TO REINFORCE WHITE SUPREMACY.

WOODWARD'S ANALYSIS OF JIM CROW

THE NATURE OF JIM CROW

1. SOCIAL AND ECONOMIC IMPLICATIONS:
 - JIM CROW LAWS NOT ONLY DICTATED WHERE AFRICAN AMERICANS COULD SIT OR ATTEND SCHOOL BUT ALSO SEVERELY RESTRICTED THEIR ECONOMIC OPPORTUNITIES.

KEY THEMES IN "THE STRANGE CAREER OF JIM CROW"

1. THE FLUIDITY OF RACISM
