2. CALIFORNIA PORTION

- AGENCY LAW

 - REAL ESTATE PRINCIPLES
 - REAL ESTATE PRACTICE
 - ONE ELECTIVE COURSE FROM A LIST OF APPROVED TOPICS (E.G., REAL ESTATE FINANCE, PROPERTY MANAGEMENT, ETC.)
4. BACKGROUND CHECK: SUBMIT FINGERPRINTS FOR A CRIMINAL BACKGROUND CHECK.

3. FIND A SPONSORING BROKER: YOU WILL NEED TO WORK UNDER A LICENSED BROKER TO PRACTICE REAL ESTATE IN CALIFORNIA.
4. CONTINUING EDUCATION: STAY INFORMED ABOUT ONGOING EDUCATION REQUIREMENTS TO MAINTAIN YOUR LICENSE.
