IMPORTANCE OF UNIFORM STANDARDS

CONTENTS OF THE CAP 39 1 UNIFORM MANUAL

2. TYPES OF UNIFORMS

- **MENTORSHIP:** EXPERIENCED MEMBERS CAN MENTOR NEWER RECRUITS, GUIDING THEM ON PROPER UNIFORM WEAR AND ADHERENCE TO STANDARDS.
- **REGULAR INSPECTIONS:** LEADERSHIP CAN CONDUCT REGULAR UNIFORM INSPECTIONS TO ENCOURAGE COMPLIANCE AND PROVIDE FEEDBACK.
