OVERVIEW OF CARF AND ITS ACCREDITATION PROCESS

THE COMMISSION ON ACCREDITATION OF REHABILITATION FACILITIES (CARF) IS A GLOBALLY RECOGNIZED ACCREDITING BODY THAT SETS QUALITY STANDARDS FOR HEALTH AND HUMAN SERVICES ORGANIZATIONS. CARF'S ACCREDITATION PROCESS INVOLVES RIGOROUS EVALUATION AGAINST A COMPREHENSIVE SET OF CRITERIA OUTLINED IN THE CARF STANDARDS MANUAL 2022. THESE STANDARDS COVER A WIDE RANGE OF SERVICE DOMAINS INCLUDING BEHAVIORAL HEALTH, REHABILITATION, AGING SERVICES, AND CHILD AND YOUTH SERVICES. ACCREDITATION BY CARF SIGNIFIES THAT AN ORGANIZATION MEETS OR EXCEEDS INDUSTRY BENCHMARKS FOR QUALITY AND CONTINUOUS IMPROVEMENT.

THIS UPDATE REQUIRES ORGANIZATIONS TO ACTIVELY ADDRESS DISPARITIES IN SERVICE ACCESS AND OUTCOMES, AND TO FOSTER INCLUSIVE ENVIRONMENTS FOR CLIENTS AND STAFF. COMPLIANCE INVOLVES IMPLEMENTING EDI TRAINING, MONITORING, AND ACCOUNTABILITY MECHANISMS.

DATA MANAGEMENT AND OUTCOME MEASUREMENT ENHANCEMENTS

DATA COLLECTION AND ANALYSIS REQUIREMENTS HAVE BEEN REFINED IN THE CARF STANDARDS MANUAL 2022 TO SUPPORT EVIDENCE-BASED PRACTICE.
