- EMPLOYEE RELATIONS AND DIVERSITY
- WORKING CONDITIONS

- CUSTOMER SATISFACTION

COMPANIES THAT EXCEL IN THESE AREAS ARE OFTEN VIEWED AS MORE SUSTAINABLE AND RESPONSIBLE.

GOVERNANCE FACTORS

GOVERNANCE DEALS WITH A COMPANY'S LEADERSHIP, EXECUTIVE PAY, AUDITS, INTERNAL CONTROLS, AND SHAREHOLDER RIGHTS. IMPORTANT ASPECTS INCLUDE:

- BOARD DIVERSITY AND STRUCTURE
- EXECUTIVE COMPENSATION
- TRANSPARENCY AND ACCOUNTABILITY
- SHAREHOLDER RIGHTS
