NUCLEOTIDES AND THEIR COMPONENTS

NUCLEOTIDES CONSIST OF THREE COMPONENTS:

1. A PHOSPHATE GROUP
2. A SUGAR MOLECULE (DEOXYRIBOSE IN DNA)
3. A NITROGENOUS BASE (ADENINE, THYMINE, CYTOSINE, OR GUANINE)

THE SEQUENCE OF THESE NITROGENOUS BASES ENCODES GENETIC INFORMATION. COMPLEMENTARY BASE PAIRING OCCURS BETWEEN ADENINE AND THYMINE, AND BETWEEN CYTOSINE AND GUANINE, WHICH IS ESSENTIAL FOR DNA REPLICATION AND TRANSCRIPTION.

DNA REPLICATION

DNA REPLICATION IS THE PROCESS BY WHICH DNA MAKES A COPY OF ITSELF DURING CELL DIVISION. THIS PROCESS ENSURES THAT EACH DAUGHTER CELL RECEIVES AN EXACT COPY OF THE PARENT CELL'S DNA.

THE STEPS OF DNA REPLICATION

THE PROCESS OF DNA REPLICATION CAN BE SUMMARIZED IN THE FOLLOWING STEPS:

1. UNWINDING: THE DOUBLE HELIX STRUCTURE OF DNA UNWINDS AND SEPARATES INTO TWO SINGLE STRANDS.
2. COMPLEMENTARY BASE PAIRING: FREE NUCLEOTIDES IN THE NUCLEUS PAIR WITH THE EXPOSED NITROGENOUS BASES ON EACH TEMPLATE STRAND.
3. FORMATION OF NEW STRANDS: DNA POLYMERASE ENZYMES SYNTHESIZE NEW STRANDS BY ADDING NUCLEOTIDES IN THE 5' TO 3' DIRECTION.
4. PROOFREADING: DNA POLYMERASE ALSO CHECKS FOR ERRORS AND CORRECTS THEM TO ENSURE FIDELITY IN DNA REPLICATION.

THIS SEMI-CONSERVATIVE PROCESS RESULTS IN TWO IDENTICAL DNA MOLECULES, EACH CONTAINING ONE ORIGINAL AND ONE NEWLY SYNTHESIZED STRAND.

TRANSCRIPTION AND TRANSLATION

ONCE DNA IS REPLICATED, THE NEXT STEPS OF GENE EXPRESSION ARE TRANSCRIPTION AND TRANSLATION. THESE PROCESSES CONVERT THE GENETIC INFORMATION STORED IN DNA INTO FUNCTIONAL PROTEINS.

TRANSCRIPTION

TRANSCRIPTION IS THE FIRST STEP IN THE PROCESS OF GENE EXPRESSION, WHERE A SPECIFIC SEGMENT OF DNA IS COPIED INTO MESSENGER RNA (mRNA).

1. INITIATION: RNA POLYMERASE BINDS TO THE PROMOTER REGION OF THE GENE.
2. ELONGATION: RNA POLYMERASE MOVES ALONG THE DNA TEMPLATE STRAND, SYNTHESIZING mRNA BY ADDING COMPLEMENTARY RNA NUCLEOTIDES.
3. TERMINATION: TRANSCRIPTION CONTINUES UNTIL RNA POLYMERASE REACHES A TERMINATOR SEQUENCE, SIGNALING THE END OF TRANSCRIPTION.

THE RESULTING mRNA MOLECULE CARRIES THE GENETIC CODE FROM THE NUCLEUS TO THE RIBOSOMES, WHERE TRANSLATION OCCURS.

TRANSLATION

TRANSLATION IS THE PROCESS BY WHICH THE mRNA SEQUENCE IS USED TO SYNTHESIZE PROTEINS. THIS PROCESS OCCURS IN THE RIBOSOME AND INVOLVES SEVERAL KEY COMPONENTS:

- mRNA: THE TRANSCRIPT OF THE GENE THAT CONTAINS CODONS (THREE-NUCLEOTIDE SEQUENCES).
- tRNA (TRANSFER RNA): MOLECULES THAT BRING AMINO ACIDS TO THE RIBOSOME, MATCHING THEIR ANTICODONS WITH THE mRNA CODONS.
- RIBOSOMES: THE CELLULAR MACHINERY THAT FACILITATES THE TRANSLATION PROCESS.

THE STEPS OF TRANSLATION

1. INITIATION: THE RIBOSOME ASSEMBLES AROUND THE mRNA, AND THE FIRST tRNA BINDS TO THE START CODON (AUG).
2. ELONGATION: tRNA MOLECULES CONTINUE TO BRING AMINO ACIDS TO THE RIBOSOME, FORMING A GROWING POLYPEPTIDE CHAIN.
3. TERMINATION: THE PROCESS CONTINUES UNTIL A STOP CODON IS REACHED, AT WHICH POINT THE POLYPEPTIDE CHAIN IS RELEASED.

THE FINAL RESULT IS A NEWLY SYNTHESIZED PROTEIN THAT PERFORMS VARIOUS FUNCTIONS WITHIN THE CELL.

IMPLICATIONS OF THE MOLECULAR BASIS OF INHERITANCE
