THE ADVOCATE CENTER IS DESIGNED TO ENHANCE PLAYER DEVELOPMENT WITH CUTTING-EDGE TRAINING TECHNOLOGY, MEDICAL FACILITIES, AND A FOCUS ON OVERALL ATHLETE WELLNESS.

CAN FANS WATCH CHICAGO BULLS PRACTICES AT THE ADVOCATE CENTER?
