

# CODE OF FEDERAL REGULATIONS TITLE 24

**CODE OF FEDERAL REGULATIONS TITLE 24** IS A CRITICAL COMPONENT OF THE UNITED STATES FEDERAL REGULATORY FRAMEWORK, SPECIFICALLY CONCERNING HOUSING AND URBAN DEVELOPMENT. THIS TITLE ENCOMPASSES A WIDE ARRAY OF REGULATIONS THAT GOVERN VARIOUS ASPECTS OF THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD), INCLUDING PUBLIC HOUSING, MULTIFAMILY HOUSING, AND COMMUNITY PLANNING AND DEVELOPMENT INITIATIVES. TITLE 24 IS ESSENTIAL FOR ENSURING THE PROVISION OF SAFE, DECENT, AND AFFORDABLE HOUSING TO ALL CITIZENS, AND IT OUTLINES THE STANDARDS AND PRACTICES THAT GOVERN THESE EFFORTS.

## OVERVIEW OF TITLE 24

TITLE 24 OF THE CODE OF FEDERAL REGULATIONS (CFR) IS A COMPILATION OF RULES AND REGULATIONS THAT PROVIDE GUIDELINES FOR FEDERAL HOUSING POLICIES. IT INCLUDES IMPORTANT PROVISIONS AIMED AT PROMOTING ACCESSIBILITY, FAIRNESS, AND SUSTAINABILITY WITHIN HOUSING PROGRAMS. THE REGULATIONS ARE DESIGNED TO SUPPORT LOW-INCOME FAMILIES, INDIVIDUALS WITH DISABILITIES, AND OTHER VULNERABLE POPULATIONS IN SECURING ADEQUATE HOUSING.

## CONTENTS OF TITLE 24

TITLE 24 IS DIVIDED INTO SEVERAL PARTS, EACH ADDRESSING A SPECIFIC AREA OF HOUSING AND URBAN DEVELOPMENT. THE KEY COMPONENTS OF TITLE 24 INCLUDE:

1. PART 1: GENERAL PROGRAM REQUIREMENTS

THIS SECTION ESTABLISHES GENERAL POLICIES AND PROCEDURES APPLICABLE TO HUD PROGRAMS.

2. PART 5: GENERAL HUD PROGRAM REQUIREMENTS

ADDRESSES REQUIREMENTS ACROSS VARIOUS HUD PROGRAMS, INCLUDING INCOME ELIGIBILITY AND VERIFICATION.

3. PART 6: NONDISCRIMINATION IN HOUSING PROGRAMS

ENFORCES FAIR HOUSING LAWS, PROHIBITING DISCRIMINATION BASED ON RACE, COLOR, NATIONAL ORIGIN, RELIGION, SEX, FAMILIAL STATUS, AND DISABILITY.

4. PART 91: CONSOLIDATED SUBMISSIONS FOR COMMUNITY PLANNING AND DEVELOPMENT PROGRAMS

OUTLINES THE PROCESS FOR STATE AND LOCAL GOVERNMENTS TO SUBMIT THEIR PLANS FOR HUD FUNDING.

5. PART 92: HOME INVESTMENT PARTNERSHIPS PROGRAM

FOCUSES ON THE HOME PROGRAM, WHICH PROVIDES GRANTS TO STATES AND LOCALITIES TO CREATE AFFORDABLE HOUSING FOR LOW-INCOME HOUSEHOLDS.

6. PART 93: EMERGENCY SOLUTIONS GRANTS PROGRAM

GOVERNS ASSISTANCE FOR HOMELESS INDIVIDUALS AND FAMILIES, INCLUDING THE PREVENTION OF HOMELESSNESS.

7. PART 100: FAIR HOUSING ACT REGULATIONS

DETAILS REGULATIONS ENFORCING THE FAIR HOUSING ACT, ENSURING EQUAL HOUSING OPPORTUNITIES.

8. PART 135: ECONOMIC OPPORTUNITIES FOR LOW- AND VERY LOW-INCOME PERSONS

MANDATES THAT HUD PROGRAMS MUST PROVIDE ECONOMIC OPPORTUNITIES FOR LOW-INCOME INDIVIDUALS.

## SIGNIFICANCE OF TITLE 24 REGULATIONS

THE REGULATIONS OUTLINED IN TITLE 24 ARE SIGNIFICANT FOR SEVERAL REASONS:

## 1. PROMOTING FAIR HOUSING

TITLE 24 PLAYS A PIVOTAL ROLE IN PROMOTING FAIR HOUSING PRACTICES ACROSS THE UNITED STATES. BY ENFORCING LAWS THAT PREVENT DISCRIMINATION, IT ENSURES THAT ALL INDIVIDUALS HAVE EQUAL ACCESS TO HOUSING OPPORTUNITIES, REGARDLESS OF THEIR BACKGROUND OR SOCIOECONOMIC STATUS.

## 2. SUPPORTING AFFORDABLE HOUSING INITIATIVES

THE PROVISIONS WITHIN TITLE 24 FOSTER THE DEVELOPMENT AND PRESERVATION OF AFFORDABLE HOUSING. THROUGH VARIOUS PROGRAMS AND FUNDING MECHANISMS, HUD CAN SUPPORT LOCAL GOVERNMENTS AND NON-PROFIT ORGANIZATIONS IN THEIR EFFORTS TO PROVIDE HOUSING FOR LOW- AND MODERATE-INCOME FAMILIES.

## 3. ADDRESSING HOMELESSNESS

THE REGULATIONS IN TITLE 24, PARTICULARLY THOSE RELATED TO THE EMERGENCY SOLUTIONS GRANTS PROGRAM, ARE VITAL IN ADDRESSING THE ISSUE OF HOMELESSNESS. THEY PROVIDE FUNDING AND RESOURCES AIMED AT PREVENTING HOMELESSNESS AND ASSISTING THOSE CURRENTLY EXPERIENCING IT.

## 4. ENSURING ACCESSIBILITY

TITLE 24 INCLUDES REQUIREMENTS FOR ACCESSIBILITY IN HOUSING DESIGN, ENSURING THAT INDIVIDUALS WITH DISABILITIES HAVE EQUAL ACCESS TO HOUSING OPPORTUNITIES. THIS IS CRUCIAL IN PROMOTING INCLUSIVE COMMUNITIES.

## KEY PROGRAMS UNDER TITLE 24

SEVERAL KEY PROGRAMS ARE ADMINISTERED UNDER TITLE 24, EACH AIMED AT ADDRESSING SPECIFIC HOUSING AND URBAN DEVELOPMENT CHALLENGES.

### 1. THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

THE CDBG PROGRAM PROVIDES FEDERAL FUNDING TO LOCAL AND STATE GOVERNMENTS FOR A RANGE OF COMMUNITY DEVELOPMENT ACTIVITIES, INCLUDING:

- HOUSING REHABILITATION
- INFRASTRUCTURE IMPROVEMENTS
- PUBLIC SERVICES
- ECONOMIC DEVELOPMENT INITIATIVES

THIS PROGRAM IS DESIGNED TO BENEFIT LOW- AND MODERATE-INCOME COMMUNITIES AND TO FOSTER SUSTAINABLE COMMUNITY DEVELOPMENT.

### 2. THE HOUSING CHOICE VOUCHER PROGRAM (SECTION 8)

THE HOUSING CHOICE VOUCHER PROGRAM, COMMONLY REFERRED TO AS SECTION 8, IS ONE OF THE MOST SIGNIFICANT FEDERAL PROGRAMS AIMED AT ASSISTING LOW-INCOME FAMILIES IN AFFORDING HOUSING. UNDER THIS PROGRAM, ELIGIBLE FAMILIES RECEIVE

VOUCHERS THAT SUBSIDIZE THEIR RENT IN THE PRIVATE MARKET, ALLOWING THEM TO CHOOSE WHERE THEY LIVE WHILE ENSURING THAT HOUSING COSTS REMAIN MANAGEABLE.

### 3. THE LOW-INCOME HOUSING TAX CREDIT (LIHTC)

THE LIHTC PROGRAM INCENTIVIZES THE DEVELOPMENT OF AFFORDABLE RENTAL HOUSING THROUGH TAX CREDITS. DEVELOPERS CAN RECEIVE TAX CREDITS FOR BUILDING OR REHABILITATING RENTAL PROPERTIES THAT MEET SPECIFIC AFFORDABILITY CRITERIA, THEREBY INCREASING THE SUPPLY OF AFFORDABLE HOUSING.

### 4. THE CONTINUUM OF CARE (CoC) PROGRAM

THE CoC PROGRAM IS DESIGNED TO PROMOTE COMMUNITY-WIDE COMMITMENT TO THE GOAL OF ENDING HOMELESSNESS. IT PROVIDES FUNDING TO NONPROFIT PROVIDERS AND STATE AND LOCAL GOVERNMENTS TO RAPIDLY REHOUSE INDIVIDUALS AND FAMILIES EXPERIENCING HOMELESSNESS, WHILE MINIMIZING THE TRAUMA AND DISLOCATION CAUSED BY HOMELESSNESS.

## COMPLIANCE AND ENFORCEMENT

COMPLIANCE WITH TITLE 24 REGULATIONS IS CRUCIAL FOR ORGANIZATIONS AND ENTITIES RECEIVING HUD FUNDING. FAILURE TO COMPLY CAN RESULT IN PENALTIES, INCLUDING THE LOSS OF FUNDING OR LEGAL ACTION. HUD CONDUCTS REGULAR AUDITS AND REVIEWS TO ENSURE ADHERENCE TO THESE REGULATIONS.

### 1. MONITORING AND AUDITS

HUD EMPLOYS A VARIETY OF METHODS TO MONITOR COMPLIANCE, INCLUDING:

- ON-SITE INSPECTIONS
- FINANCIAL AUDITS
- PROGRAM REVIEWS

THESE MECHANISMS HELP ENSURE THAT FUNDS ARE BEING USED APPROPRIATELY AND THAT PROGRAMS ARE MEETING THEIR INTENDED GOALS.

### 2. REPORTING REQUIREMENTS

ENTITIES RECEIVING HUD FUNDING ARE TYPICALLY REQUIRED TO SUBMIT REGULAR REPORTS DETAILING THEIR PROGRAM ACTIVITIES, FINANCIAL EXPENDITURES, AND OUTCOMES ACHIEVED. THESE REPORTS ARE ESSENTIAL FOR HUD TO ASSESS PROGRAM EFFECTIVENESS AND COMPLIANCE.

## CHALLENGES AND FUTURE DIRECTIONS

WHILE TITLE 24 HAS MADE SIGNIFICANT STRIDES IN PROMOTING AFFORDABLE HOUSING AND FAIR HOUSING PRACTICES, CHALLENGES REMAIN. ISSUES SUCH AS RISING HOUSING COSTS, GENTRIFICATION, AND THE ONGOING IMPACT OF THE COVID-19 PANDEMIC HAVE CREATED BARRIERS TO ACHIEVING HOUSING EQUITY.

## 1. INCREASING HOUSING AFFORDABILITY

THE CHALLENGE OF AFFORDABILITY REMAINS A PRESSING CONCERN. PROGRAMS UNDER TITLE 24 MUST EVOLVE TO ADDRESS THE INCREASING COST OF HOUSING AND ENSURE THAT LOW-INCOME INDIVIDUALS AND FAMILIES CAN STILL ACCESS SAFE AND AFFORDABLE HOMES.

## 2. ADDRESSING SYSTEMIC INEQUITIES

SYSTEMIC INEQUITIES IN HOUSING ACCESS AND QUALITY MUST BE ADDRESSED. TITLE 24 REGULATIONS NEED TO BE CONTINUALLY REVIEWED AND UPDATED TO ELIMINATE BARRIERS FACED BY MARGINALIZED COMMUNITIES.

## 3. EMPHASIZING SUSTAINABILITY

AS CLIMATE CHANGE BECOMES AN INCREASINGLY URGENT ISSUE, TITLE 24 MUST INCORPORATE SUSTAINABILITY MEASURES INTO HOUSING DEVELOPMENT AND URBAN PLANNING. THIS INCLUDES PROMOTING ENERGY-EFFICIENT BUILDING PRACTICES AND ENSURING THAT HOUSING DEVELOPMENTS ARE RESILIENT TO CLIMATE-RELATED DISASTERS.

## CONCLUSION

IN SUMMARY, THE CODE OF FEDERAL REGULATIONS TITLE 24 PLAYS A VITAL ROLE IN SHAPING HOUSING POLICY AND PROMOTING EQUITABLE ACCESS TO HOUSING IN THE UNITED STATES.
