 - SOFT TISSUES (MUSCLES, TENDONS)

EACH REGION IS TYPICALLY PRESENTED WITH A COMBINATION OF LABELED ULTRASOUND IMAGES AND CORRESPONDING ANATOMICAL DIAGRAMS TO FACILITATE UNDERSTANDING.

3. PATHOLOGICAL CONDITIONS
