PRACTICAL SKILLS ASSESSMENT

SUCCESSFUL COMPLETION OF BOTH THE WRITTEN EXAMINATION AND PRACTICAL SKILLS ASSESSMENT IS REQUIRED TO EARN CERTIFICATION AS A DRIVER OPERATOR OF A PUMPER.

PREPARATION STRATEGIES
