3. TEST ANXIETY

FEELING ANXIOUS ABOUT THE EXAM IS COMMON. TO ALLEVIATE ANXIETY:

- PRACTICE RELAXATION TECHNIQUES, SUCH AS DEEP BREATHING OR MINDFULNESS.
