CORE ETHICAL PRINCIPLES IN NURSING

AT THE HEART OF CONCEPTS AND CASES IN NURSING ETHICS ARE SEVERAL CORE PRINCIPLES THAT GUIDE NURSES IN DELIVERING CARE THAT RESPECTS PATIENTS' RIGHTS AND DIGNITY. THESE PRINCIPLES FORM THE ETHICAL FOUNDATION NECESSARY FOR QUALITY NURSING PRACTICE AND INCLUDE AUTONOMY, BENEFICENCE, NON-MALEFICENCE, AND JUSTICE. EACH PRINCIPLE ADDRESSES DIFFERENT ASPECTS OF ETHICAL CARE AND HELPS NURSES NAVIGATE COMPLEX SITUATIONS.

AUTONOMY

AUTONOMY REFERS TO RESPECTING A PATIENT'S RIGHT TO MAKE INFORMED DECISIONS ABOUT THEIR OWN HEALTHCARE. NURSES MUST ENSURE PATIENTS RECEIVE ALL RELEVANT INFORMATION AND SUPPORT TO MAKE VOLUNTARY, UNCOERCED CHOICES. UPHOLDING AUTONOMY INVOLVES HONORING PATIENTS' VALUES, PREFERENCES, AND CULTURAL BACKGROUNDS, EVEN WHEN THEY DIFFER FROM THE NURSE'S PERSONAL BELIEFS.

BENEFICENCE AND NON-MALEFICENCE

BENEFICENCE INVOLVES ACTING IN THE BEST INTEREST OF THE PATIENT BY PROMOTING GOOD AND PREVENTING HARM. NON-MALEFICENCE COMPLEMENTS THIS BY EMPHASIZING THE DUTY TO AVOID CAUSING HARM. NURSES BALANCE THESE PRINCIPLES BY CAREFULLY WEIGHING THE BENEFITS AND RISKS OF INTERVENTIONS, ENSURING THAT CARE ENHANCES PATIENT WELLBEING WITHOUT UNNECESSARY SUFFERING OR INJURY.

JUSTICE

JUSTICE IN NURSING ETHICS ENTAILS FAIRNESS IN THE DISTRIBUTION OF HEALTHCARE RESOURCES AND IMPARTIAL TREATMENT OF ALL PATIENTS. NURSES MUST ADVOCATE FOR EQUITABLE ACCESS TO CARE REGARDLESS OF PATIENTS' AGE, GENDER, SOCIOECONOMIC STATUS, OR ETHNICITY. THIS PRINCIPLE SUPPORTS THE ELIMINATION OF DISCRIMINATION AND BIAS WITHIN

COMMON ETHICAL DILEMMAS IN NURSING PRACTICE

NURSES FREQUENTLY ENCOUNTER ETHICAL DILEMMAS THAT CHALLENGE THEIR PROFESSIONAL JUDGMENT AND MORAL VALUES. UNDERSTANDING COMMON ISSUES IN CONCEPTS AND CASES IN NURSING ETHICS PREPARES NURSES TO RESPOND APPROPRIATELY AND MAINTAIN ETHICAL INTEGRITY.

CONFIDENTIALITY AND PRIVACY

MAINTAINING PATIENT CONFIDENTIALITY IS A FUNDAMENTAL ETHICAL OBLIGATION. NURSES MUST PROTECT SENSITIVE INFORMATION WHILE NAVIGATING SITUATIONS WHERE DISCLOSURE MAY BE NECESSARY, SUCH AS RISK OF HARM TO THE PATIENT OR OTHERS. BALANCING PRIVACY WITH SAFETY CONCERNS OFTEN PRESENTS DIFFICULT DECISIONS.

INFORMED CONSENT

OBTAINING INFORMED CONSENT ENSURES THAT PATIENTS AGREE TO TREATMENTS WITH FULL AWARENESS OF POTENTIAL RISKS AND BENEFITS. NURSES PLAY A CRITICAL ROLE IN FACILITATING THIS PROCESS BY PROVIDING CLEAR EXPLANATIONS AND VERIFYING COMPREHENSION, ESPECIALLY WHEN PATIENTS HAVE COMMUNICATION BARRIERS OR COGNITIVE IMPAIRMENTS.

END-OF-LIFE CARE

END-OF-LIFE SITUATIONS OFTEN INVOLVE CHALLENGING ETHICAL QUESTIONS ABOUT LIFE-SUSTAINING TREATMENTS, PALLIATIVE CARE, AND PATIENT WISHES. NURSES MUST RESPECT ADVANCE DIRECTIVES AND INVOLVE PATIENTS AND FAMILIES IN CARE PLANNING WHILE MANAGING EMOTIONAL AND ETHICAL COMPLEXITIES.

CASE 3: RESOURCE ALLOCATION

ETHICAL DECISION-MAKING MODELS IN NURSING

THE FOUR-BOX METHOD

LEGAL AND PROFESSIONAL STANDARDS IN NURSING ETHICS
