COSA NOSTRA: A HISTORY OF THE SICILIAN MAFIA

THE TERM "COSA NOSTRA," TRANSLATING TO "OUR THING," REFERS TO THE SICILIAN MAFIA, AN ORGANIZED CRIME SYNDICATE THAT HAS SHAPED THE SOCIAL AND POLITICAL LANDSCAPE OF SICILY AND BEYOND FOR MORE THAN A CENTURY. - CAPODECINA: A CAPTAIN WHO SUPERVISES A GROUP OF SOLDIERS AND ENFORCES THE BOSS'S ORDERS.
- SOLDIERS: THE FOOT SOLDIERS WHO CARRY OUT THE FAMILY'S CRIMINAL ACTIVITIES.
- ASSOCIATES: NON-MEMBERS WHO WORK WITH THE FAMILY BUT DO NOT HAVE FULL MEMBERSHIP.

CRIMINAL ACTIVITIES

COSA NOSTRA HAS BEEN INVOLVED IN A WIDE RANGE OF CRIMINAL ENTERPRISES, WHICH HAVE EVOLVED OVER TIME:

1. TRADITIONAL ACTIVITIES

- EXTORTION: THE PRACTICE OF DEMANDING PAYMENT FOR PROTECTION OR TO AVOID VIOLENCE; KNOWN AS "PIZZO."
- SMUGGLING: ENGAGING IN THE ILLEGAL TRADE OF GOODS, ESPECIALLY DURING TIMES OF ECONOMIC HARDSHIP.
- MURDER AND ASSASSINATION: A METHOD OF ENFORCING SILENCE AND LOYALTY AMONG MEMBERS AND ENEMIES.

2. MODERN CRIMINAL ENTERPRISES

WITH GLOBALIZATION, COSA NOSTRA ADAPTED AND EXPANDED ITS OPERATIONS:

- DRUG TRAFFICKING: INVOLVEMENT IN THE IMPORT AND DISTRIBUTION OF NARCOTICS, WHICH HAS BECOME ONE OF THEIR MOST LUCRATIVE VENTURES.
- MONEY LAUNDERING: USING LEGITIMATE BUSINESSES TO CONCEAL THE ORIGINS OF ILLICIT FUNDS.
