- **PRESERVATIVES:** TO PREVENT MICROBIAL GROWTH AND EXTEND PRODUCT SHELF LIFE, PRESERVATIVES LIKE PARABENS OR PHENOXYETHANOL ARE INCLUDED IN FORMULATIONS.
- **FRAGRANCE AND COLORANTS:** THESE INGREDIENTS ENHANCE THE SENSORY EXPERIENCE OF A PRODUCT BUT SHOULD BE USED JUDICIOUSLY TO AVOID SKIN IRRITATION.

THE FORMULATION PROCESS

CREATING A SUCCESSFUL SKIN CARE PRODUCT INVOLVES SEVERAL STAGES, EACH REQUIRING CAREFUL CONSIDERATION AND EXPERTISE.
