2. MATHEMATICAL ABILITY

THE MATH SECTION INCLUDES BASIC ARITHMETIC OPERATIONS, PERCENTAGES, RATIOS, AND PROBLEM-SOLVING SCENARIOS RELEVANT TO LAW ENFORCEMENT CONTEXTS. YOU MAY NEED TO PERFORM CALCULATIONS RELATED TO TIME, DISTANCE, AND OTHER PRACTICAL APPLICATIONS.

3. REASONING SKILLS

THIS PART OF THE EXAM EVALUATES YOUR LOGICAL REASONING, CRITICAL THINKING, AND ABILITY TO ANALYZE INFORMATION. YOU MAY BE PRESENTED WITH STATEMENTS OR SCENARIOS AND ASKED TO DRAW CONCLUSIONS OR IDENTIFY LOGICAL INCONSISTENCIES.

4. SITUATIONAL JUDGMENT

SITUATIONAL JUDGMENT QUESTIONS SIMULATE REAL-LIFE SCENARIOS THAT LAW ENFORCEMENT OFFICERS MAY ENCOUNTER. YOU WILL NEED TO CHOOSE THE MOST APPROPRIATE RESPONSE BASED ON ETHICAL CONSIDERATIONS, LEGAL STANDARDS, AND BEST PRACTICES IN POLICING.

PREPARING FOR THE EXAM

PREPARATION IS KEY TO EXCELLING IN THE WRITTEN EXAM. HERE ARE SOME EFFECTIVE STRATEGIES TO HELP YOU STUDY:

1. UNDERSTAND THE EXAM FORMAT

TEST-TAKING STRATEGIES

4. STAY CALM AND FOCUSED

EXAM ANXIETY CAN HINDER PERFORMANCE. PRACTICE RELAXATION TECHNIQUES, SUCH AS DEEP BREATHING, TO HELP MAINTAIN FOCUS AND CALMNESS DURING THE TEST.

POST-EXAM CONSIDERATIONS

ONCE YOU COMPLETE THE WRITTEN EXAM, THERE ARE SEVERAL STEPS TO CONSIDER:

1. REVIEW YOUR PERFORMANCE

IF YOUR SCORE IS MADE AVAILABLE, TAKE THE TIME TO REVIEW THE RESULTS. IDENTIFY AREAS WHERE YOU EXCELLED AND THOSE THAT MAY NEED IMPROVEMENT FOR FUTURE ASSESSMENTS.

2. PREPARE FOR SUBSEQUENT STEPS

IF YOU PASS THE WRITTEN EXAM, YOU MAY ADVANCE TO OTHER STAGES OF THE APPLICATION PROCESS, SUCH AS PHYSICAL FITNESS TESTS, INTERVIEWS, AND BACKGROUND CHECKS. PREPARE FOR THESE STAGES BY RESEARCHING THE REQUIREMENTS AND PRACTICING NECESSARY SKILLS.
