CPT FOR WELLNESS EXAM CODES ARE ESSENTIAL FOR HEALTHCARE PROVIDERS AIMING TO BILL FOR PREVENTIVE SERVICES EFFECTIVELY. CPT CODES FOR WELLNESS EXAMS

SEVERAL CPT CODES SPECIFICALLY CATER TO WELLNESS EXAMS. THE CODES VARY BASED ON FACTORS SUCH AS THE PATIENT'S AGE, THE TYPE OF EXAM CONDUCTED, AND THE SERVICES PROVIDED DURING THE VISIT.

COMMON CPT CODES FOR ADULT WELLNESS EXAMS

FOR ADULT PATIENTS, THE FOLLOWING CPT CODES ARE COMMONLY USED FOR WELLNESS EXAMS:

- **99381:** INITIAL COMPREHENSIVE PREVENTIVE MEDICINE EVALUATION AND MANAGEMENT OF AN INDIVIDUAL, INCLUDING A COMPREHENSIVE HISTORY AND EXAMINATION, TYPICALLY IN A NEW PATIENT.

- **99382:** INITIAL PREVENTIVE MEDICINE EVALUATION AND MANAGEMENT OF AN INDIVIDUAL, TYPICALLY IN AN ESTABLISHED PATIENT.
- **99383:** PERIODIC COMPREHENSIVE PREVENTIVE MEDICINE REEVALUATION AND MANAGEMENT OF AN INDIVIDUAL, INCLUDING A COMPREHENSIVE HISTORY AND EXAMINATION.
- **99384:** INITIAL COMPREHENSIVE PREVENTIVE MEDICINE EVALUATION AND MANAGEMENT OF AN INDIVIDUAL, TYPICALLY IN A NEW PATIENT, AGE 18-39.

COMMON CPT CODES FOR PEDIATRIC WELLNESS EXAMS

FOR PEDIATRIC PATIENTS, WELLNESS EXAMS ARE EQUALLY IMPORTANT, AND THE FOLLOWING CPT CODES APPLY:

- **99391:** INITIAL COMPREHENSIVE PREVENTIVE MEDICINE EVALUATION AND MANAGEMENT OF AN INDIVIDUAL, TYPICALLY IN A NEW PATIENT, AGE 0-1.
- **99392:** INITIAL PREVENTIVE MEDICINE EVALUATION AND MANAGEMENT OF AN INDIVIDUAL, TYPICALLY IN AN ESTABLISHED PATIENT, AGE 1-4.
- **99393:** PERIODIC COMPREHENSIVE PREVENTIVE MEDICINE REEVALUATION AND MANAGEMENT OF AN INDIVIDUAL, TYPICALLY IN AN ESTABLISHED PATIENT, AGE 5-11.
- **99394:** INITIAL COMPREHENSIVE PREVENTIVE MEDICINE EVALUATION AND MANAGEMENT OF AN INDIVIDUAL, TYPICALLY IN A NEW PATIENT, AGE 12-17.

BEST PRACTICES FOR USING CPT CODES IN WELLNESS EXAMS

TO ENSURE ACCURATE CODING AND BILLING FOR WELLNESS EXAMS, HEALTHCARE PROVIDERS SHOULD CONSIDER THE FOLLOWING BEST PRACTICES:

1. STAY UPDATED ON CHANGES

CPT CODES ARE UPDATED REGULARLY, SO IT'S VITAL FOR HEALTHCARE PROVIDERS TO STAY INFORMED ABOUT ANY CHANGES THAT MAY AFFECT THEIR PRACTICE. REGULARLY REVIEWING CPT CODE UPDATES CAN HELP IN MINIMIZING CODING ERRORS.

2. DOCUMENT THOROUGHLY

ACCURATE DOCUMENTATION OF THE SERVICES PROVIDED DURING WELLNESS EXAMS IS ESSENTIAL. DETAILED NOTES CAN SUPPORT THE USE OF SPECIFIC CPT CODES AND JUSTIFY THE SERVICES BILLED.

3. UNDERSTAND PREVENTIVE SERVICES COVERAGE
