UNDERSTANDING CRIMINAL HISTORY RECORDS CHECK (CHRC) IN TEXAS

THE CRIMINAL HISTORY RECORDS CHECK (CHRC) IN TEXAS IS A FORMAL PROCESS THROUGH WHICH AN INDIVIDUAL OR AN AUTHORIZED ENTITY OBTAINS A COMPREHENSIVE REPORT OF AN INDIVIDUAL'S CRIMINAL BACKGROUND. THIS REPORT IS COMPILED FROM DATA COLLECTED BY THE TEXAS DEPARTMENT OF PUBLIC SAFETY (DPS), INCLUDING FELONY AND MISDEMEANOR CONVICTIONS, ARRESTS, AND OTHER RELEVANT LAW ENFORCEMENT INFORMATION. THE CHRC IS A VITAL TOOL FOR MAINTAINING PUBLIC SAFETY AND ENSURING INFORMED DECISION-MAKING IN EMPLOYMENT, LICENSING, AND OTHER SENSITIVE AREAS.

ROLE OF THE TEXAS DEPARTMENT OF PUBLIC SAFETY

THE TEXAS DEPARTMENT OF PUBLIC SAFETY IS THE CENTRAL AUTHORITY RESPONSIBLE FOR MAINTAINING THE CRIMINAL RECORDS DATABASE AND PROCESSING CHRC REQUESTS. THE DPS COLLECTS DATA FROM LOCAL, STATE, AND FEDERAL LAW ENFORCEMENT AGENCIES TO ENSURE THAT THE CRIMINAL HISTORY RECORDS ARE ACCURATE AND UP-TO-DATE. THE DEPARTMENT ALSO ENSURES COMPLIANCE WITH STATE AND FEDERAL LAWS GOVERNING THE DISSEMINATION OF CRIMINAL HISTORY INFORMATION.

TYPES OF CRIMINAL HISTORY RECORDS AVAILABLE

CRIMINAL HISTORY RECORDS IN TEXAS CAN INCLUDE VARIOUS TYPES OF INFORMATION, SUCH AS:

- ARREST RECORDS
- CONVICTIONS FOR MISDEMEANORS AND FELONIES
- PENDING CRIMINAL CHARGES

- GOVERNMENT AGENCIES AND LAW ENFORCEMENT

REQUESTERS MUST COMPLY WITH STATE AND FEDERAL REGULATIONS, INCLUDING OBTAINING APPROPRIATE AUTHORIZATIONS AND CONSENTS.

METHODS FOR SUBMITTING A CHRC REQUEST

THE TEXAS DPS PROVIDES MULTIPLE METHODS FOR SUBMITTING A CHRC REQUEST, INCLUDING:

- ONLINE SUBMISSION THROUGH THE TEXAS DPS WEBSITE
- MAIL-IN FINGERPRINT CARD SUBMISSION
- IN-PERSON REQUESTS AT DESIGNATED DPS LOCATIONS

FINGERPRINT-BASED REQUESTS ARE THE MOST ACCURATE METHOD FOR OBTAINING A CRIMINAL HISTORY RECORD, AS THEY REDUCE THE RISK OF MISIDENTIFICATION. THE DPS REQUIRES THE USE OF STANDARD FINGERPRINT CARDS THAT MUST BE COMPLETED BY AUTHORIZED PERSONNEL OR LAW ENFORCEMENT.

INFORMATION INCLUDED IN A TEXAS CHRC REPORT

THE CRIMINAL HISTORY RECORDS CHECK CHRC TEXAS REPORT PROVIDES DETAILED INFORMATION ABOUT AN INDIVIDUAL'S CRIMINAL BACKGROUND AS RECORDED IN THE STATE DATABASE. THIS INFORMATION IS CRITICAL FOR MAKING INFORMED DECISIONS IN VARIOUS CONTEXTS.

THESE DETAILS HELP EMPLOYERS AND AGENCIES VERIFY THE CRIMINAL BACKGROUND OF INDIVIDUALS IN A COMPREHENSIVE AND OFFICIAL MANNER.

LIMITATIONS AND EXCLUSIONS

WHILE THE CHRC REPORT IS THOROUGH, CERTAIN RECORDS MAY NOT BE INCLUDED DUE TO EXPUNGEMENT, NON-DISCLOSURE ORDERS, OR RECORDS SEALED BY THE COURTS. ADDITIONALLY, JUVENILE RECORDS ARE TYPICALLY CONFIDENTIAL AND MAY NOT APPEAR ON STANDARD CRIMINAL HISTORY REPORTS.

LEGAL AND PRIVACY CONSIDERATIONS FOR CHRC IN TEXAS

CONDUCTING A CRIMINAL HISTORY RECORDS CHECK CHRC TEXAS REQUIRES STRICT ADHERENCE TO LEGAL GUIDELINES DESIGNED TO PROTECT INDIVIDUAL PRIVACY AND PREVENT MISUSE OF SENSITIVE INFORMATION.

COMPLIANCE WITH THE FAIR CREDIT REPORTING ACT (FCRA)

THIS INCLUDES OBTAINING WRITTEN CONSENT FROM THE INDIVIDUAL, PROVIDING NOTICES OF ADVERSE ACTIONS, AND ENSURING THE ACCURACY OF THE INFORMATION USED.

STATE PRIVACY LAWS AND RESTRICTIONS

TEXAS LAW IMPOSES ADDITIONAL RESTRICTIONS ON THE DISSEMINATION AND USE OF CRIMINAL HISTORY INFORMATION. FOR EXAMPLE, CERTAIN OFFENSES MAY BE EXCLUDED FROM REPORTS, AND THE USE OF THE INFORMATION MUST BE RELEVANT TO THE PURPOSE OF THE REQUEST. UNAUTHORIZED USE OR DISCLOSURE OF CRIMINAL HISTORY RECORDS CAN RESULT IN PENALTIES.

COSTS AND PROCESSING TIME OF A TEXAS CRIMINAL HISTORY RECORD CHECK

FEE STRUCTURE FOR CHRC REQUESTS

THE TEXAS DEPARTMENT OF PUBLIC SAFETY CHARGES FEES FOR PROCESSING CHRC REQUESTS. THE FEES VARY BASED ON WHETHER THE REQUEST IS ELECTRONIC OR FINGERPRINT-BASED AND WHETHER THE REQUESTER IS AN INDIVIDUAL OR AN AGENCY. GENERALLY, FEES RANGE FROM \$10 TO \$25 PER CHECK, WITH ADDITIONAL COSTS FOR FINGERPRINTING SERVICES WHEN APPLICABLE.

TYPICAL PROCESSING TIMES

PROCESSING TIMES FOR CHRC REPORTS CAN VARY:

- ELECTRONIC REQUESTS OFTEN RETURN RESULTS WITHIN 1 TO 3 BUSINESS DAYS
- FINGERPRINT CARD SUBMISSIONS MAY TAKE 7 TO 14 BUSINESS DAYS
- IN-PERSON REQUESTS MAY BE PROCESSED IMMEDIATELY OR WITHIN A FEW DAYS DEPENDING ON LOCATION

TIMELY PROCESSING IS ESSENTIAL FOR EMPLOYMENT AND LICENSING DECISIONS THAT DEPEND ON CURRENT CRIMINAL BACKGROUND INFORMATION.

COMMON USES OF CRIMINAL HISTORY RECORDS CHECK CHRC TEXAS
