DEFINITIONS AND SCOPE OF CRIMINAL JUSTICE AND POLITICAL SCIENCE

UNDERSTANDING CRIMINAL JUSTICE

CRIMINAL JUSTICE IS THE SYSTEM OF PRACTICES AND INSTITUTIONS AIMED AT UPHOLDING SOCIAL CONTROL, DETERRING AND MITIGATING CRIME, AND SANCTIONING THOSE WHO VIOLATE LAWS WITH CRIMINAL PENALTIES AND REHABILITATION EFFORTS. THIS FIELD ENCOMPASSES LAW ENFORCEMENT AGENCIES, THE JUDICIAL SYSTEM, CORRECTIONS, AND THE STUDY OF CRIME PREVENTION STRATEGIES. IT INVOLVES UNDERSTANDING LEGAL CODES, CRIMINAL BEHAVIOR, FORENSIC SCIENCE, AND THE RIGHTS OF INDIVIDUALS WITHIN THE JUSTICE SYSTEM.

UNDERSTANDING POLITICAL SCIENCE

CRIMINAL JUSTICE DEGREE PROGRAMS

PROGRAMS AT THE BACHELOR'S AND MASTER'S LEVELS MAY ALSO INCLUDE INTERNSHIPS WITH LAW ENFORCEMENT AGENCIES OR COURT SYSTEMS TO PROVIDE EXPERIENTIAL LEARNING.

POLITICAL SCIENCE DEGREE PROGRAMS

POLITICAL SCIENCE CURRICULA EMPHASIZE POLITICAL THEORY, COMPARATIVE POLITICS, INTERNATIONAL RELATIONS, PUBLIC ADMINISTRATION, AND POLICY ANALYSIS. COURSEWORK OFTEN INCLUDES THE STUDY OF POLITICAL INSTITUTIONS, POLITICAL PHILOSOPHY, QUANTITATIVE METHODS, AND GLOBAL POLITICS. POLITICAL SCIENCE STUDENTS DEVELOP CRITICAL THINKING SKILLS TO ANALYZE POLITICAL BEHAVIOR, ELECTORAL TRENDS, AND GOVERNMENT POLICIES, PREPARING THEM FOR RESEARCH OR ROLES IN PUBLIC SERVICE.

CAREER OPPORTUNITIES AND JOB OUTLOOK

CAREERS IN CRIMINAL JUSTICE

GRADUATES IN CRIMINAL JUSTICE HAVE DIVERSE CAREER PATHS, INCLUDING ROLES AS POLICE OFFICERS, PROBATION OFFICERS, FORENSIC ANALYSTS, CRIME SCENE INVESTIGATORS, CORRECTIONAL OFFICERS, AND LEGAL AIDES. CAREERS IN POLITICAL SCIENCE

POLITICAL SCIENCE GRADUATES OFTEN ENTER CAREERS IN GOVERNMENT, PUBLIC ADMINISTRATION, POLICY ANALYSIS, POLITICAL CONSULTING, INTERNATIONAL ORGANIZATIONS, OR ACADEMIA. POSITIONS MAY INCLUDE LEGISLATIVE ASSISTANTS, POLITICAL ANALYSTS, CAMPAIGN MANAGERS, DIPLOMATS, AND PUBLIC AFFAIRS SPECIALISTS. THE FIELD OFFERS OPPORTUNITIES TO INFLUENCE PUBLIC POLICY, GOVERNANCE, AND INTERNATIONAL RELATIONS, WITH DEMAND LINKED TO THE COMPLEXITY OF GOVERNMENTAL AND POLITICAL PROCESSES WORLDWIDE.

RESEARCH METHODS AND ANALYTICAL APPROACHES

RESEARCH IN CRIMINAL JUSTICE
