HISTORICAL CONTEXT AND DEVELOPMENT

CORE PRINCIPLES OF CRITICAL PRACTICE

THE EFFECTIVENESS OF CRITICAL PRACTICE IN SOCIAL WORK DEPENDS ON ADHERENCE TO SEVERAL FOUNDATIONAL PRINCIPLES THAT GUIDE PRACTITIONERS IN THEIR WORK. THESE PRINCIPLES EMPHASIZE A COMMITMENT TO SOCIAL JUSTICE, CLIENT EMPOWERMENT, AND ONGOING CRITICAL REFLECTION.

SOCIAL JUSTICE AND EQUALITY

POLICY ADVOCACY AND SOCIAL CHANGE
