TYPES OF CSL LICENSES

1. **UNRESTRICTED LICENSE:** THIS LICENSE ALLOWS THE HOLDER TO SUPERVISE ANY TYPE OF CONSTRUCTION WORK, INCLUDING COMMERCIAL BUILDINGS, IRRESPECTIVE OF THE PROJECT SIZE.
