4. GEOMETRY

- IDENTIFYING SHAPES AND THEIR ATTRIBUTES (SIDES, ANGLES)
- UNDERSTANDING SPATIAL RELATIONSHIPS (ABOVE, BELOW, NEXT TO)
- INTRODUCTION TO SYMMETRY AND CONGRUENCE

5. MATHEMATICAL PRACTICES

- PROBLEM-SOLVING STRATEGIES
- REASONING AND EXPLAINING MATHEMATICAL THINKING
- ENGAGING WITH MATHEMATICAL CONCEPTS THROUGH PLAY AND EXPLORATION

EFFECTIVE PREPARATION STRATEGIES FOR CST MATH PRACTICE TESTS

TIPS FOR ADMINISTERING CST MATH PRACTICE TESTS

- BE AVAILABLE TO ANSWER QUESTIONS OR CLARIFY INSTRUCTIONS, BUT AVOID PROVIDING DIRECT ANSWERS TO THE TEST QUESTIONS.
- ENCOURAGE PROBLEM-SOLVING STRATEGIES AND CRITICAL THINKING RATHER THAN ROTE MEMORIZATION.

5. REVIEW AND DISCUSS RESULTS

- AFTER THE TEST, REVIEW THE ANSWERS WITH THE CHILDREN TO REINFORCE LEARNING.
- DISCUSS WHICH AREAS THEY FOUND EASY AND WHICH WERE CHALLENGING, SETTING GOALS FOR FUTURE PRACTICE.
