ELIGIBILITY REQUIREMENTS FOR THE DC REAL ESTATE EXAM

BEFORE TAKING THE DC REAL ESTATE EXAM, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA SET BY THE DISTRICT OF COLUMBIA REAL ESTATE COMMISSION. THESE REQUIREMENTS ENSURE THAT APPLICANTS POSSESS THE FOUNDATIONAL QUALIFICATIONS NECESSARY FOR LICENSURE. PRE-LICENSING EDUCATION
