- THE TIGERS WON THEIR FIRST WORLD SERIES TITLE IN 1935.
- NAVIN FOCUSED ON IMPROVING THE TEAM'S FACILITIES AND INVESTING IN PLAYER DEVELOPMENT.
- HE WAS INSTRUMENTAL IN BUILDING THE ICONIC NAVIN FIELD, WHICH LATER BECAME KNOWN AS TIGER STADIUM.

THE POST-WAR PERIOD: THE NAVIN AND BRIGGS FAMILIES (1935-1959)

AFTER FRANK NAVIN'S DEATH IN 1935, OWNERSHIP OF THE TEAM TRANSFERRED TO HIS FAMILY. THE BRIGGS FAMILY, WHO HAD A MINORITY STAKE SINCE 1919, BECAME MORE INVOLVED IN THE TEAM'S OPERATIONS.

THE BRIGGS FAMILY INFLUENCE

- THE BRIGGS FAMILY EMPHASIZED MAINTAINING A COMPETITIVE TEAM, LEADING TO FURTHER SUCCESS.
- UNDER THEIR OWNERSHIP, THE TIGERS SECURED ANOTHER WORLD SERIES TITLE IN 1945.
- THE TEAM FACED CHALLENGES, INCLUDING FINANCIAL HARDSHIPS AFTER WORLD WAR II AND THE DECLINE OF THE AMERICAN AUTOMOTIVE INDUSTRY.

THE 1960S AND 1970S: THE BIRTH OF THE FREE AGENT ERA

IN THE LATE 1950S, THE TIGERS WERE SOLD TO JOHN FETZER, A LOCAL MEDIA MOGUL. FETZER'S OWNERSHIP MARKED A NEW CHAPTER IN THE TEAM'S HISTORY.

JOHN FETZER'S TENURE

- FETZER WAS KNOWN FOR HIS PROGRESSIVE APPROACH TO TEAM MANAGEMENT AND WAS AN ADVOCATE FOR PLAYER RIGHTS.
- HE HELPED ESTABLISH THE FREE AGENT SYSTEM, ALLOWING PLAYERS MORE FREEDOM IN CONTRACT NEGOTIATIONS.

FOLLOWING FETZER'S DEATH IN 1988, THE TEAM UNDERWENT VARIOUS OWNERSHIP CHANGES. THE MOST NOTABLE WAS THE SALE OF THE TEAM TO MIKE ILITCH IN 1992.

THE MIKE ILITCH ERA

- MIKE ILITCH, FOUNDER OF LITTLE CAESARS PIZZA, INVESTED HEAVILY IN THE TEAM AND AIMED TO RESTORE ITS FORMER GLORY.
- HIS OWNERSHIP SAW THE TIGERS WINNING THE WORLD SERIES IN 1984, MARKING A HIGH POINT FOR THE FRANCHISE.
- ILITCH'S COMMITMENT TO IMPROVING THE TEAM'S FACILITIES CULMINATED IN THE CONSTRUCTION OF COMERICA PARK, WHICH OPENED IN 2000.

THE 21ST CENTURY: THE ILITCH FAMILY AND BEYOND (2000-PRESENT)

AFTER MIKE ILITCH'S DEATH IN 2017, HIS FAMILY CONTINUED TO OPERATE THE TEAM. THE ILITCH FAMILY REMAINS DEEPLY INVOLVED IN THE TIGERS' MANAGEMENT AND HAS FOCUSED ON MAINTAINING THE FRANCHISE'S COMPETITIVE EDGE.

CURRENT OWNERSHIP STRUCTURE

- THE TIGERS ARE NOW OWNED BY THE ILITCH FAMILY, WITH CHRISTOPHER ILITCH AS THE CEO.
- THE FAMILY HAS MADE SIGNIFICANT INVESTMENTS IN PLAYER DEVELOPMENT AND SCOUTING TO REBUILD THE TEAM.
- DESPITE CHALLENGES, SUCH AS FINANCIAL STRAINS AND COMPETITIVE STRUGGLES, THE ILITCH FAMILY REMAINS COMMITTED TO THE TIGERS AND THE CITY OF DETROIT.

IMPACT OF OWNERSHIP ON THE DETROIT TIGERS
